

Our People

Nurturing Families



Knowing that college students will soon begin to transition from the fast food world to the work world, a manners lesson during a formal dinner was offered by the FCS agent. The program was the final session of a leadership class held for 40 students. As a result of the program, almost half of those who responded to the survey 6 weeks following the program had changed the way they shake hands, 100% had the opportunity to put their new manners to use and 89% had shared the information with family and friends.¹

Our Families

Using data from the 2000 U.S. Census, Daviess County families can be described as follows:²

- 25,016 families reside in the county.
- 2,364 families (9.4%) live below poverty level.
- Median family income is \$45,404.
- 633 grandparents are responsible for the care of their grandchildren.

According to the Kentucky Cabinet for Health and Family Services, 11,709 people in Daviess County receive food stamps. The average family food stamp benefit is \$213.38 per month.3

In the county, **496** children live in out-of-home care.⁴ In 2004, there were 239 incidents of adult abuse and **546** incidents of child abuse.⁵

As a result of participation in Daviess County Extension programs:1

- 98% of food stamp recipients or eligible recipients enrolled in the nutrition education program improved their diet.
- 352 people increased their knowledge and skills related to parenting and personal relationships.
- 123 people adopted money management practices to reduce debt and/or increase savings.
- 1,211 people used safe practices to store, handle and prepare food.

Our Community

Unemployment rates are a key economic indicator. In September 2008, the rate of unemployment in Daviess County was 6.3%. This represented a 34% increase from the September 2007 level of 4.7%.6

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Daviess County, 90-day mortgage delinquency rates have increased by 6% and 60-day bank card delinquency rates have increased by **34%**. In a six-month period (May through October 2008), 140 foreclosures were filed.8

Access to health insurance is another important factor contributing to family well-being. In Daviess County, 11% of the people under age 65 are uninsured.9


As a result of participation in Daviess County Extension programs:1

- 143 citizens enhanced their leadership skills by participation in leadership programs.
- 61 people were involved in addressing issues of their community.
- Daviess County Extension is involved in 13 community coalitions.

Our Health

The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Daviess County.

As a result of participation in Daviess County Extension programs:1

- 1,175 people implemented new practices to maintain health and well-being.
- 1,311 people gained knowledge and skills to make lifestyle changes to improve their health.
- 1,175 people made lifestyle changes to improve physical health.
