

Family and Consumer Sciences Extension made **8,018** contacts with Edmonson County families during 2007-2008.<sup>1</sup>

#### **Our People**

The 2000 U.S. Census reported total population as **11,644**.<sup>2</sup> The graph below indicates the percentage by age group.

### **Nurturing Families**

As both an anti-drug activity and a way to promote strong families, the UK Cooperative Extension Service in Edmonson County established a Family Meal Club. The club met three times. Parents and teen children prepared 192 meals for an average cost of .95 cents per serving in a little over four hours. Families felt they gained food preparation skills, money saving advice and time saving strategies. One member noted, "This has been a great experience for my daughter and me, we've both learned new skills and more about each other. These meals have been a real life saver when we are in a time crunch."

#### **Our Families**

Using data from the 2000 U.S. Census, Edmonson County families can be described as follows:<sup>2</sup>

- 3,502 families reside in the county.
- 497 families (14.2%) live below poverty level.
- Median family income is \$31,843.
- **87** grandparents are responsible for the care of their grandchildren.

According to the Kentucky Cabinet for Health and Family Services, **1,900** people in Edmonson County receive food stamps. The average family food stamp benefit is **\$188.29** per month.<sup>3</sup>

In the county, **49** children live in out-of-home care.<sup>4</sup> In 2004, there were **17** incidents of adult abuse and **102** incidents of child abuse.<sup>5</sup>

# As a result of participation in Edmonson County Extension programs:<sup>1</sup>

- 97 % of food stamp recipients or eligible recipients enrolled in the nutrition education program improved their diet.
- **730** people gained knowledge and skills to make lifestyle changes to improve their health.
- **70** people adopted money management practices to reduce debt and/or increase savings.
- **120** people used safe practices to store, handle and prepare food.

#### **Our Community**

Unemployment rates are a key economic indicator. In September 2008, the rate of unemployment in Edmonson County was **7.2%**. This represented a **29%** increase from the September 2007 level of **5.6%**. 6

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Edmonson County, 90-day mortgage delinquency rates have increased by 33% and 60-day bank card delinquency rates have increased by 89%. In a six-month period (May through October 2008), 2 foreclosures were filed.

Access to health insurance is another important factor contributing to family well-being. In Edmonson County, **14%** of the people under age 65 are uninsured.<sup>9</sup>


## As a result of participation in Edmonson County Extension programs:<sup>1</sup>

- **60** citizens enhanced their leadership skills by participation in leadership programs.
- 100 adults and youth utilized improved communication, problem solving, and group process skills to address community needs.
- **180** people were involved in addressing issues of their community.

#### **Our Health**

The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Edmonson County.

# As a result of participation in Edmonson County Extension programs:<sup>1</sup>

- **100** people implemented new practices to maintain health and well-being.
- **190** people increased their use of radon testers, smoke detectors, fire extinguishers, and other devices to ensure personal safety.
- **200** people made lifestyle changes to improve physical health.
