

Our People

The 2000 U.S. Census reported total population as **260,512**.² The graph below indicates the percentage by age group.

Spotlight on . . .

Making Beneficial Lifestyle Choices



The UK College of Medicine in collaboration with Fayette County Extension and other community agencies formed a new partnership to address the high number of students in the 85th percentile of body mass index (BMI), putting them at risk for obesity. Fifty students from a limited resource elementary school were targeted based upon their highest BMI status. The project included workshops for students and parents focused on risk factors for obesity. Seventy percent of the students reduced daily calories and fat in diet; 70% tracked and increased activity; 100% increased sit down family meals; and 100% served vegetables daily. Ninety-five percent of students gained new health careers information with 85% indicating specific interest. 1

Our Families

Using data from the 2000 U.S. Census, Fayette County families can be described as follows:²

- 63,648 families reside in the county.
- 5,218 families (8.2%) live below poverty level.
- Median family income is \$53,264.
- **1,946** grandparents are responsible for the care of their grandchildren.

According to the Kentucky Cabinet for Health and Family Services, **24,494** people in Fayette County receive food stamps. The average family food stamp benefit is **\$223.17** per month.³

In the county, **1,027** children live in out-of-home care.⁴ In 2004, there were **374** incidents of adult abuse and **914** incidents of child abuse.⁵

As a result of participation in Fayette County Extension programs:¹

- 98% of food stamp recipients or eligible recipients enrolled in the nutrition education program improved their diet.
- **35,000** adults and youth improved their ability to make informed and effective decisions.
- 25,000 people adopted money management practices to reduce debt and/or increase savings.
- **1,200** people used safe practices to store, handle and prepare food.

Our Community

Unemployment rates are a key economic indicator. In September 2008, the rate of unemployment in Fayette County was **5.1%**. This represented a **28%** increase from the September 2007 level of **4%**.⁶

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Fayette County, 90-day mortgage delinquency rates have increased by **22%** and 60-day bank card delinquency rates have increased by **7%**. In a six-month period (May through October 2008), **471** foreclosures were filed.

Access to health insurance is another important factor contributing to family well-being. In Fayette County, **13%** of the people under age 65 are uninsured.⁹


As a result of participation in Fayette County Extension programs:¹

- **2,500** citizens enhanced their leadership skills by participation in leadership programs.
- County Extension is involved in **70** community coalitions.
- **54,336** people were involved in addressing issues of their community.

Our Health

The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Fayette County.

As a result of participation in Fayette County Extension programs:¹

- **44,000** people made lifestyle changes to improve physical health.
- **50,000** people implemented new practices to maintain health and well-being.
- 1,000 people increased their use of radon testers, smoke detectors, fire extinguishers, and other devices to ensure personal safety.
