



NURTURING FAMILIES

he Community Action of Southern Kentucky Foster Grandparent program reaches out to people who are over age 60 and are economically disadvantaged. Currently, 43% of Foster Grandparents are from minority populations. In an effort to teach basic money management skills the Foster Grandparent program partnered with Barren County Cooperative Extension Service to offer the series, Small Steps to Health and Wealth. This program was designed to help the 95 participants set small goals to increase their well-being and financial management. As a result of the program 100 percent of participants reported an increase in knowledge

concerning wise eating and activity behaviors. 80 percent of participants indicated that knowledge was gained concerning personal financial behaviors and 75 percent reported setting either a financial or health related goal.¹





OUR COMMUNITY

► Unemployment rates are a key economic indicator. In August 2009, the rate of unemployment in Barren County was 12.3%.³

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Barren

As a result of participation in Barren County Extension programs:¹


- 118 people were involved in addressing issues of their community.
- 78 people increased their knowledge of governmental process.
- 62 people expanded their knowledge of economic development.

County, **2.64%** of mortgages are 90-days delinquent and 60-day bank card delinquency rates have increased by **1.58%**.⁴ In a one-year period (October 2008 through October 2009), **143** foreclosures were filed.⁵

Access to health insurance is another important factor contributing to family well-being. In Barren County, **14%** of the people under age 65 are uninsured.⁶

OUR HEALTH

► The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Barren County. Figure 2. Health Risks.⁶




As a result of participation in Barren County Extension programs:¹

- **308** people increased knowledge of practices to maintain health and well-being.
- **316** people increased knowledge of safe practices to store, handle, and prepare food.
- **2,410** people increased their use of radon testers, smoke detectors, fire extinguishers, and other devices to ensure personal safety.

OUR FAMILIES

- ► Using data from the 2000 U.S. Census, Barren County families can be described as follows:²
- 10,939 families reside in the county.
- 1,303 families (11.8%) live below poverty level.
- Median family income is \$37,231.
- 211 grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **2,821** people in Barren County receive food stamps. The average family food stamp benefit is **\$209.34** per month.⁷

In the county, 144 children live in out-of-home care.8

In 2005, there were **232** incidents of adult abuse and **202** incidents of child abuse.⁹

As a result of participation in Barren County Extension programs:¹

- **526** adults and youth improved their ability to make informed and effective decisions.
- 113 people adopted money management practices to reduce debt and/or increase savings.
- 42 adult or childcare providers increased their knowledge and skills related to appropriate age care.
