



PROMOTING HEALTHY HOMES AND COMMUNITIES

any health problems continue due to physical inactivity. Changes in our built environment through good sidewalks can provide citizens with an avenue to become more physically active. In order to encourage physical activity in the community, the Bullitt County Cooperative Extension Service, the city of Mt. Washington and the Main Street Committee worked to address their downtown built environment. A design was created to improve the atmosphere, visual appeal and ease of walking throughout the city. Because of this project work, the city was awarded an \$110,000 stimulus grant

through Kentuckiana Regional Planning & Development Agency for sidewalk improvements. With improved sidewalks and a pleasant atmosphere, barriers to physical activity will be removed in order to promote better health.¹





OUR COMMUNITY

► Unemployment rates are a key economic indicator. In August 2009, the rate of unemployment in Bullitt County was 10.8%.³

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Bullitt County,

As a result of participation in Bullitt County Extension programs:


- 266 people were involved in addressing issues of their community.
- 341 people increased their knowledge of governmental process.
- 197 people expanded their knowledge of economic development.

3.99% of mortgages are 90-days delinquent and 60-day bank card delinquency rates have increased by **1.84%**.⁴ In a one-year period (October 2008 through October 2009), **327** foreclosures were filed.⁵

Access to health insurance is another important factor contributing to family well-being. In Bullitt County, **9%** of the people under age 65 are uninsured.⁶

OUR HEALTH

► The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Bullitt County. Figure 2. Health Risks.⁶




As a result of participation in Bullitt County Extension programs:¹

- **360** people increased knowledge of practices to maintain health and well-being.
- 686 people made lifestyle changes to improve health.
- **464** people increased their use of radon testers, smoke detectors, fire extinguishers, and other devices to ensure personal safety.

OUR FAMILIES

- ▶ Using data from the 2000 U.S. Census, Bullitt County families can be described as follows:²
- 17,745 families reside in the county.
- 1,110 families (6.2%) live below poverty level.
- Median family income is \$49,481.
- **575** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **2,668** people in Bullitt County receive food stamps. The average family food stamp benefit is **\$232.98** per month.⁷

In the county, **167** children live in out-of-home care.⁸

In 2005, there were **315** incidents of adult abuse and **91** incidents of child abuse.⁹

As a result of participation in Bullitt County Extension programs:¹

- 315 adults and youth improved their ability to make informed and effective decisions.
- 43 people increased their knowledge and skills related to parenting and personal relationships.
- 97 adults or child care providers increased their knowledge and skills related to age appropriate care.
