



arly detection and information on risk reduction is a benefit offered to the citizens of Butler County for a healthier life through the many opportunities to participate in the Community Health Fairs offered/sponsored by the Butler County Cooperative Extension Service FCS Agent. Screenings offered were blood cholesterol, blood glucose, blood pressure, skin cancer, vision, hearing, prostate cancer, flu shots, and body composition. 468 individuals participated in the screenings held throughout the year. During the screenings, one individual identi-

fied severe hearing loss in her left ear, another was found to have very low blood sugar, while another was found to have blood pressure so high that immediate attention was required.1





OUR COMMUNITY

► Unemployment rates are a key economic indicator. In August 2009, the rate of unemployment in Butler County was 14.8%.³

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Butler County,

As a result of participation in Butler County Extension programs:¹


- 103 people were involved in addressing issues in their community.
- 154 people increased their knowledge of governmental process.
- **26** people were prepared to enter the workforce.

1.35% of mortgages are 90-days delinquent and 60-day bank card delinquency rates have increased by **1.15**%.⁴ In a one-year period (October 2008 through October 2009), **6** foreclosures were filed.⁵

Access to health insurance is another important factor contributing to family well-being. In Butler County, **14%** of the people under age 65 are uninsured.⁶

OUR HEALTH

► The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Butler County. Figure 2. Health Risks.⁶




As a result of participation in Butler County Extension programs:¹

- **571** people increased knowledge of practices to maintain health and well-being.
- 528 people made lifestyle changes to improve health.
- **468** people implemented practices to maintain health and well-being.

OUR FAMILIES

- ► Using data from the 2000 U.S. Census, Butler County families can be described as follows:²
- 3,709 families reside in the county.
- 488 families (13.1%) live below poverty level.
- Median family income is \$35,317.
- **126** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **987** people in Butler County receive food stamps. The average family food stamp benefit is **\$199.76** per month.⁷

In the county, **55** children live in out-of-home care.⁸

In 2005, there were **29** incidents of adult abuse and **51** incidents of child abuse.⁹

As a result of participation in Butler County Extension programs:¹

- 459 adults and youth improved their ability to make informed and effective decisions.
- 9 people adopted money management practices to reduce debt and/or increase savings.
- **289** adults and youth improved practical living skills.
