



SPOTLIGHT ON...

MAKING BENEFICIAL LIFESTYLE CHOICES

n order to address risk factors for later-life cardiovascular disease, educational programs which address the importance of healthy nutrition, increased physical activity, and improved literacy are needed. Campbell County Extension collaborated with two daycares and two kindergarten classes. 100 preschoolers participated in the 10-session curriculum called LEAP (Literacy, Eating, and Activity for Preschoolers) for Health. Storybooks were used to teach children the importance of staying healthy, being physically active, and eating more fruits and

vegetables. Each session included reading the story, tasting foods introduced in the story, and a reinforcement activity such as jumping rope or discussing how to brush one's teeth. 1





OUR COMMUNITY

► Unemployment rates are a key economic indicator. In August 2009, the rate of unemployment in Campbell County was 10.3%.³

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community wellbeing. In Campbell

As a result of participation in Campbell County Extension programs:¹


- 910 people were involved in addressing issues of their community.
- **193** people were prepared to enter the work force.
- 452 people expanded their knowledge of economic development.

County, **2.72%** of mortgages are 90-days delinquent and 60-day bank card delinquency rates have increased by **1.54%**.⁴ In a one-year period (October 2008 through October 2009), **399** foreclosures were filed.⁵

Access to health insurance is another important factor contributing to family well-being. In Campbell County, **8%** of the people under age 65 are uninsured.⁶

OUR HEALTH

► The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Campbell County. *Figure 2. Health Risks.*⁶




As a result of participation in Campbell County Extension programs:¹

- **859** people increased knowledge of practices to maintain health and well-being.
- 450 people made lifestyle changes to improve health.
- **386** people increased their use of radon testers, smoke detectors, fire extinguishers, and other devices to ensure personal safety.

OUR FAMILIES

- ▶ Using data from the 2000 U.S. Census, Campbell County families can be described as follows:²
- 23,093 families reside in the county.
- 1,708 families (7.3%) live below poverty level.
- Median family income is \$51,481.
- **639** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, 3,448 people in Campbell County receive food stamps. The average family food stamp benefit is \$230.63 per month.⁷

In the county, 147 children live in out-of-home care.8

In 2005, there were **290** incidents of adult abuse and **118** incidents of child abuse.⁹

As a result of participation in Campbell County Extension programs:¹

- 1,963 adults and youth improved their ability to make informed and effective decisions.
- 81 people adopted money management practices to reduce debt and/or increase savings.
- 164 people increased their knowledge and skills related to parenting and personal relationships.
