OUR FOCUS



besity and its related conditions, especially diabetes, is one of the major health issues in Elliott County. This year, in addition to offering the "Dining With Diabetes" program, we offered "Cooking School with Chef Bob" to address the problem. We limited the four-night cooking school to 20 people. Participants ranged in age from 11 to 82 years and, through hands-on activities, learned to preserve foods, to judge portion size using the plate method, to calculate their calorie needs and prepare foods using the My Pyramid food guide to adapt recipes to make them more nutritious, and to cook with herbs and spices. In an evaluation afterward, participants rated it as the best program they had attended.¹





OUR COMMUNITY

► Unemployment rates are a key economic indicator. In August 2009, the rate of unemployment in Elliott County was 13%.³

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Elliott County,

As a result of participation in Elliott County Extension programs:¹


- 113 people were involved in addressing issues of their community.
- 143 people increased their knowledge of governmental process.
- 25 people expanded their knowledge of economic development.

2.86% of mortgages are 90-days delinquent and 60-day bank card delinquency rates have increased by **1.20%**.⁴ In a one-year period (October 2008 through October 2009), **6** foreclosures were filed.⁵

Access to health insurance is another important factor contributing to family well-being. In Elliott County, **18**% of the people under age 65 are uninsured.⁶

OUR HEALTH

► The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Elliott County. Figure 2. Health Risks.⁶




As a result of participation in Elliott County Extension programs:¹

- **247** people increased knowledge of practices to maintain health and well-being.
- 133 people made lifestyle changes to improve health.
- 177 people increased knowledge of safe practices to store, handle, and prepare food.

OUR FAMILIES

- ▶ Using data from the 2000 U.S. Census, Elliott County families can be described as follows:²
- 1,926 families reside in the county.
- 400 families (20.8%) live below poverty level.
- Median family income is \$27,125.
- **82** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **896** people in Elliott County receive food stamps. The average family food stamp benefit is **\$207.60** per month.⁷

In the county, **14** children live in out-of-home care.⁸

In 2005, there were **6** incidents of adult abuse and **62** incidents of child abuse.⁹

As a result of participation in Elliott County Extension programs:¹

- 318 adults and youth improved their ability to make informed and effective decisions.
- 292 people increased their knowledge and skills related to parenting and personal relationships.
- **40** adult or child care providers increased their knowledge and skills related to age appropriate care.
