

SPOTLIGHT ON...

MAKING BENEFICIAL LIFESTYLE CHOICES

Statistics show that 32.4 percent of Kentuckians are obese, a condition that is directly related to diabetes and other chronic problems. Thus, Floyd County leaders pledged to educate people about the condition and to provide programs to help improve their personal and family wellness. Collaborative efforts led by the Family and Consumer Sciences agent focused on delivering programs such as “Weight, The Reality Series” and “Small Steps to Health and Wealth,” as well as presenting nutrition education. People with a Body Mass Index (BMI) of 25 or higher were targeted for our weight management programs, and participants were encouraged to lose 5 percent of their body weight. More than 175 people participated in our programs, two-thirds of whom reduced their BMI by 3 percent or more.¹



OUR COMMUNITY

► Unemployment rates are a key economic indicator. In August 2009, the rate of unemployment in Floyd County was **12.6%**.³

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Floyd County, **2.36%** of mortgages are 90-days delinquent and 60-day bank card delinquency rates have increased by **1.50%**.⁴ In a one-year period (October 2008 through October 2009), **3** foreclosures were filed.⁵


Access to health insurance is another important factor contributing to family well-being. In Floyd County, **18%** of the people under age 65 are uninsured.⁶

As a result of participation in Floyd County Extension programs:¹

- **694** people were involved in addressing issues of their community.
- **378** people increased their knowledge of governmental process.
- **425** people were involved in working with government in addressing significant community issues.

OUR HEALTH

► The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Floyd County. *Figure 2. Health Risks.*⁶




As a result of participation in Floyd County Extension programs:¹

- **400** people increased knowledge of practices to maintain health and well-being.
- **298** people developed skills to access affordable food.
- **238** people implemented practices to maintain health and well-being.

OUR FAMILIES

► Using data from the 2000 U.S. Census, Floyd County families can be described as follows:²

- **12,267** families reside in the county.
- **3,330** families (**26.9%**) live below poverty level.
- Median family income is **\$25,717**.
- **434** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **5,496** people in Floyd County receive food stamps. The average family food stamp benefit is **\$206.16** per month.⁷

In the county, **135** children live in out-of-home care.⁸

In 2005, there were **153** incidents of adult abuse and **280** incidents of child abuse.⁹

As a result of participation in Floyd County Extension programs:¹

- **725** adults and youth improved their ability to make informed and effective decisions.
- **137** people adopted money management practices to reduce debt and/or increase savings.
- **93** people increased their knowledge and skills related to parenting and personal relationships.
