



SPOTLIGHT ON...

ACCESSING NUTRITIOUS FOOD

rayson County Extension made more than 600 contacts with preschoolers during the 10-session "Learning, Eating, and Activity for Preschool (LEAP)" program. The Family and Consumer Sciences agent read books related to food themes and led children in activities related to the books, including taste-testing various foods. Participating preschool teachers, as well as the agent, noted that children progressively tasted more food and requested additional food as the sessions continued. In addition, the children reported that they asked their parents to buy at least one of the foods tasted during the program, and the teachers reported that parents

began bringing more nutritious snacks for the class. A follow-up evaluation with the teachers showed that, overall, the children were eating better and were more willing to try new foods.¹





OUR COMMUNITY

► Unemployment rates are a key economic indicator. In August 2009, the rate of unemployment in Grayson County was **16.5%**.³

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community wellbeing. In Grayson

As a result of participation in Grayson County Extension programs:¹


- 53 people were involved in addressing issues of their community.
- 11 people increased their knowledge of governmental process.
- **5** people were prepared to enter the work force.

County, **2.67%** of mortgages are 90-days delinquent and 60-day bank card delinquency rates have increased by **2.38%**.⁴ In a one-year period (October 2008 through October 2009), **77** foreclosures were filed.⁵

Access to health insurance is another important factor contributing to family well-being. In Grayson County, **15%** of the people under age 65 are uninsured.⁶

OUR HEALTH

➤ The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Grayson County. *Figure 2. Health Risks.*⁶




As a result of participation in Grayson County Extension programs:¹

- **420** people increased knowledge of practices to maintain health and well-being.
- 385 people made lifestyle changes to improve health.
- **126** people used safe practices to store, handle, and prepare food.

OUR FAMILIES

- ▶ Using data from the 2000 U.S. Census, Grayson County families can be described as follows:²
- 6,966 families reside in the county.
- 970 families (13.9%) live below poverty level.
- Median family income is \$33,080.
- **261** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **2,064** people in Grayson County receive food stamps. The average family food stamp benefit is **\$206.29** per month.⁷

In the county, 87 children live in out-of-home care.8

In 2005, there were **48** incidents of adult abuse and **78** incidents of child abuse.⁹

As a result of participation in Grayson County Extension programs:¹

- 432 adults and youth improved their ability to make informed and effective decisions.
- 310 people adopted money management practices to reduce debt and/or increase savings.
- 13 people increased their knowledge and skills related to parenting and personal relationships.
