

Figure 1. Population by Age Group² (n=13,373)



PROMOTING HEALTHY HOMES AND COMMUNITIES

ue to LaRue County's low literacy rates and the need for quality early childhood education, the Family and Consumer Sciences agent helped establish the LaRue County Early Childhood Council. The council, which focuses on pre-kindergarten children and their caregivers, provides free or low-cost training, expertise and visibility that have greatly enhanced early care in the county. For example, all participating child care centers and in-home caregivers have reported a noticeable improvement in learning skills since they began using council-provided educational materials. The increased visibility of this program has led to increasing numbers of child care providers participating in the scholars

program, with four centers having staff who are using the state's scholarship funds for child care providers. Five providers are current participants in the STARS quality rating system.¹





OUR COMMUNITY

► Unemployment rates are a key economic indicator. In August 2009, the rate of unemployment in LaRue County was 11.3%.³

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In LaRue County,

As a result of participation in LaRue County Extension programs:¹


- 165 people were involved in addressing issues of their community.
- 140 people increased their knowledge of governmental process.
- 345 people expanded their knowledge of economic development.

1.60% of mortgages are 90-days delinquent and 60-day bank card delinquency rates have increased by **2.33%**.⁴ In a one-year period (October 2008 through October 2009), **9** foreclosures were filed.⁵

Access to health insurance is another important factor contributing to family well-being. In LaRue County, **13%** of the people under age 65 are uninsured.⁶

OUR HEALTH

► The health of our people contributes to quality of life. The chart below illustrates health risks of adults in LaRue County. Figure 2. Health Risks.⁶




As a result of participation in LaRue County Extension programs:¹

- **365** people increased knowledge of practices to maintain health and well-being.
- 239 people increase knowledge of safe practices to store, handle, and prepare food.
- 258 people implemented practices to maintain health and well-being.

OUR FAMILIES

- ▶ Using data from the 2000 U.S. Census, LaRue County families can be described as follows:²
- 3,866 families reside in the county.
- 487 families (12.6%) live below poverty level.
- Median family income is \$37,786.
- **103** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **893** people in LaRue County receive food stamps. The average family food stamp benefit is **\$208.08** per month.⁷

In the county, 78 children live in out-of-home care.8

In 2005, there were **59** incidents of adult abuse and **36** incidents of child abuse.⁹

As a result of participation in LaRue County Extension programs:¹

- 235 adults and youth improved their ability to make informed and effective decisions.
- **75** people adopted money management practices to reduce debt and/or increase savings.
- **52** people increased their knowledge and skills related to parenting and personal relationships.
