



NURTURING FAMILIES

ince 2001, the Allen, Logan, Simpson Community Early Childhood Council (CECC) has been granted more than \$250,000 to provide training and resource materials for the child care providers in those three counties. This year the council used some of that funding to provide three different trainings, including professional development training on cultural diversity. Forty-three local child care providers received three hours of training, after which 90 percent of participants reported increased knowledge about cultural diversity. All participants received classroom resource kits with arts, humanities and literacy materials reflective of different cultures.

The council also provided a parent involvement activity related to cultural diversity by hosting a "Kids on the Block" multiculturalism puppet show for parents and young children in each of the three counties.¹





OUR COMMUNITY

► Unemployment rates are a key economic indicator. In August 2009, the rate of unemployment in Logan County was 11%.³

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Logan County,

As a result of participation in Logan County Extension programs:¹


- 450 people were involved in addressing issues of their community.
- **800** people were prepared to enter the work force.
- 1,200 people expanded their knowledge of economic development.

2.88% of mortgages are 90-days delinquent and 60-day bank card delinquency rates have increased by **2.07**%.⁴ In a one-year period (October 2008 through October 2009), **4** foreclosures were filed.⁵

Access to health insurance is another important factor contributing to family well-being. In Logan County, **13%** of the people under age 65 are uninsured.⁶

OUR HEALTH

► The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Logan County. Figure 2. Health Risks.⁶




As a result of participation in Logan County Extension programs:¹

- **1,600** people increased knowledge of practices to maintain health and well-being.
- **75** people increase knowledge of safe practices to store, handle, and prepare food.
- **150** people implemented practices to maintain health and well-being.

OUR FAMILIES

- ► Using data from the 2000 U.S. Census, Logan County families can be described as follows:²
- 7,577 families reside in the county.
- 819 families (10.8%) live below poverty level.
- Median family income is \$39,307.
- **313** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **1,669** people in Logan County receive food stamps. The average family food stamp benefit is **\$210.93** per month.⁷

In the county, 77 children live in out-of-home care.8

In 2005, there were **84** incidents of adult abuse and **52** incidents of child abuse.⁹

As a result of participation in Logan County Extension programs:¹

- 175 adults and youth improved their ability to make informed and effective decisions.
- 600 people adopted money management practices to reduce debt and/or increase savings.
- **100** people increased their knowledge and skills related to parenting and personal relationships.
