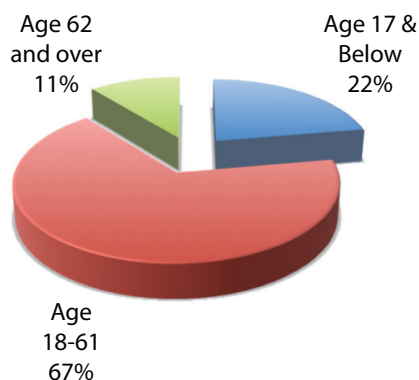

## SPOTLIGHT ON...

## EMBRACING LIFE AS YOU AGE

**M**adison County Extension was one of several community organizations that joined forces to address the need for women's health education in the county. We took the lead role in sponsoring "Hot Women and Health, Information for Premenopausal Women and Beyond." Four "lunch and learn" programs were presented to the 20-35 women who attended each session. Participants who completed evaluations said they had an increased awareness of and confidence in recognizing the risks and symptoms of conditions and diseases discussed. They also said they were more cognizant of available screenings and planned to make healthier choices, including getting check-ups and screenings to lower their risks and improve the probability of early detection. And they planned to encourage others to do the same.<sup>1</sup>



## OUR COMMUNITY

► Unemployment rates are a key economic indicator. In August 2009, the rate of unemployment in Madison County was **9.6%**.<sup>3</sup>

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Madison County, **2.64%** of mortgages are 90-days delinquent and 60-day bank card delinquency rates have increased by **1.63%**.<sup>4</sup> In a one-year period (October 2008 through October 2009), **249** foreclosures were filed.<sup>5</sup>

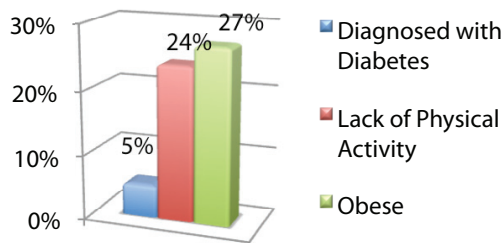
Access to health insurance is another important factor contributing to family well-being. In Madison County, **13%** of the people under age 65 are uninsured.<sup>6</sup>

### As a result of participation in Madison County Extension programs:<sup>1</sup>

- **635** people were involved in addressing issues of their community.
- **412** people were prepared to enter the work force.
- **1,235** people expanded their knowledge of economic development.

## OUR HEALTH

► The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Madison County. **Figure 2. Health Risks.**<sup>6</sup>



### As a result of participation in Madison County Extension programs:<sup>1</sup>

- **4,000** people increased knowledge of practices to maintain health and well-being.
- **2,300** people increase knowledge of safe practices to store, handle, and prepare food.
- **3,449** people increased their use of radon testers, smoke detectors, fire extinguishers, and other devices to ensure personal safety.

## OUR FAMILIES

► Using data from the 2000 U.S. Census, Madison County families can be described as follows:<sup>2</sup>

- **18,218** families reside in the county.
- **2,204** families (**12%**) live below poverty level.
- Median family income is **\$41,383**.
- **546** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **4,652** people in Madison County receive food stamps. The average family food stamp benefit is **\$226.44** per month.<sup>7</sup>

In the county, **38** children live in out-of-home care.<sup>8</sup>

In 2005, there were **219** incidents of adult abuse and **98** incidents of child abuse.<sup>9</sup>

### As a result of participation in Madison County Extension programs:<sup>1</sup>

- **6,423** adults and youth improved their ability to make informed and effective decisions.
- **788** people adopted money management practices to reduce debt and/or increase savings.
- **1,099** people increased their knowledge and skills related to parenting and personal relationships.
