

MAKING BENEFICIAL LIFESTYLE CHOICES

ccording to "The Health of Kentucky: A County Assessment," 27 percent of Martin County adults are obese, while 59 percent of adults in the county get little physical activity. In an effort to stem this tide, Martin County Extension offered "Weight, The Reality Series," with our Family and Consumer Sciences agent as the presenter. The physical activity program was offered at two separate locations and times to encourage increased attendance. Average attendance for each meeting was seven people. Total weight loss was more than 30 pounds. Participants tried new foods and found at least one new fruit or vegetable and a recipe they would use again.¹





OUR COMMUNITY

Unemployment rates are a key economic indicator. In August 2009, the rate of unemployment in Martin County was 12.9%.³

Mortgage and bank card delinguency rates and foreclosure filings are important financial indicators of community well-being. In Martin

As a result of participation in Martin County **Extension programs:**¹


- 140 people were involved in addressing issues of their community.
- 150 people increased their knowledge of governmental process.
- 55 people were prepared to enter the work force.

County, 60-day bank card delinquency rates have increased by **89%**.⁴ In a one-year period (October 2008 through October 2009), 2 foreclosures were filed.⁵

Access to health insurance is another important factor contributing to family well-being. In Martin County, 19% of the people under age 65 are uninsured.⁶

OUR HEALTH

The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Martin County. Figure 2. Health Risks.⁶



As a result of participation in **Martin County Extension programs:**¹

- 450 people increased knowledge of practices to maintain health and well-being.
- 103 people increase knowledge of safe practices to store, handle, and prepare food.
- 400 people developed skills to access affordable food.

OUR FAMILIES

- Using data from the 2000 U.S. Census, Martin County families can be described as follows:²
- 3,621 families reside in the county.
- 1,211 families (33.3%) live below poverty level.
- Median family income is \$21,574.
- 122 grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, 1,817 people in Martin County receive food stamps. The average family food stamp benefit is **\$209.20** per month.7

In the county, 206 children live in out-of-home care.8

In 2005, there were 54 incidents of adult abuse and 136 incidents of child abuse.9

As a result of participation in Martin County Extension programs:¹

- 400 adults and youth improved their ability to make informed and effective decisions.
- 300 people adopted money management practices to reduce debt and/or increase savings.
- 100 adults and youth improved practical living skills.
