



SECURING FINANCIAL STABILITY

national study shows that nearly 60 percent of Americans do not have a will. This seems to be the trend in Meade County as well. As a result, Meade County Cooperative Extension partnered with local attorneys, financial planners and a funeral director to offer a series of programs related to estate planning. Topics included how to select a lawyer, the role of a financial planner and preplanning a funeral. The Family and Consumer Sciences agent presented a segment on the importance of keeping financial records and organization. Seventy-two residents participated in the series. In a follow-up survey, 80 percent indicated they now have a record keeping system, 60 percent now have a valid will and 20 percent have formally preplanned their funerals.¹





OUR COMMUNITY

► Unemployment rates are a key economic indicator. In August 2009, the rate of unemployment in Meade County was 12%.³

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community wellbeing. In Meade


- 38 people were involved in addressing issues of their community.
- **346** people were prepared to enter the work force.
- 81 people expanded their knowledge of economic development.

County, **2.27%** of mortgages are 90-days delinquent and 60-day bank card delinquency rates have increased by **1.70%**.⁴ In a one-year period (October 2008 through October 2009), **107** foreclosures were filed.⁵

Access to health insurance is another important factor contributing to family well-being. In Meade County, **14%** of the people under age 65 are uninsured.⁶

OUR HEALTH

➤ The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Meade County. Figure 2. Health Risks.⁶




As a result of participation in Meade County Extension programs:¹

- **431** people increased knowledge of practices to maintain health and well-being.
- **491** people used safe practices to store, handle, and prepare food.
- 238 people implemented practices to maintain health and well-being.

OUR FAMILIES

- ► Using data from the 2000 U.S. Census, Meade County families can be described as follows:²
- 7,393 families reside in the county.
- 695 families (9.3%) live below poverty level.
- Median family income is \$40,592.
- **316** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, 1,035 people in Meade County receive food stamps. The average family food stamp benefit is \$244.11 per month.⁷

In the county, **40** children live in out-of-home care.⁸

In 2005, there were **50** incidents of adult abuse and **43** incidents of child abuse.⁹

As a result of participation in Meade County Extension programs:¹

- 399 adults and youth improved their ability to make informed and effective decisions.
- 18 people adopted money management practices to reduce debt and/or increase savings.
- 26 adult or child care providers increased their knowledge and skills related to age appropriate care.
