



ACCESSING NUTRITIOUS FOOD

ess than 85 percent of adults living in Lee and Owsley counties eat five or more servings of fruits and vegetables per day and more than 40 percent report no leisure-time physical activity. As a result, these counties are among those in Kentucky with the highest incidence of adult obesity. What's more, the child poverty rate in these counties averages 43.7 percent. With this in mind, the Owsley and Lee county Family and Consumer Sciences programs developed the Food Stamp Nutrition Education Program (FSNEP) project to increase fruit and vegetable consumption and physical activity The project

targeted kindergarten through third-grade students and their families. Preand post-evaluations were conducted, and a substantial increase was noted in fruit and vegetable consumption and physical activity.¹





OUR COMMUNITY

► Unemployment rates are a key economic indicator. In August 2009, the rate of unemployment in Owsley County was 11.9%.³

There was no information for Owsley in terms of foreclosure, mortgage, or credit card delinquency.

Access to health insurance is another


As a result of participation in Owsley County Extension programs:¹

- 1,220 people were involved in addressing issues of their community.
- 472 people increased their knowledge of governmental process.
- 806 people expanded their knowledge of economic development.

important factor contributing to family well-being. In Owsley County, **25%** of the people under age 65 are uninsured.⁴

OUR HEALTH

➤ The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Owsley County. *Figure 2. Health Risks.*⁴




As a result of participation in Owsley County Extension programs:¹

- **2,189** people increased knowledge of practices to maintain health and well-being.
- 1,273 people used safe practices to store, handle, and prepare food.
- **2,510** people implemented practices to maintain health and well-being.



OUR FAMILIES

- ► Using data from the 2000 U.S. Census, Owsley County families can be described as follows:²
- 1,388 families reside in the county.
- 587 families (41.7%) live below poverty level.
- Median family income is \$18,034.
- **140** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, 1,174 people in Owsley County receive food stamps. The average family food stamp benefit is \$176.15 per month.5

In the county, 11 children live in out-of-home care.⁶

In 2005, there were **8** incidents of adult abuse and **39** incidents of child abuse.⁷

As a result of participation in Owsley County Extension programs:¹

- 890 adults and youth improved their ability to make informed and effective decisions
- 422 people adopted money management practices to reduce debt and/or increase savings.
- 775 people increased their knowledge and skills related to parenting and personal relationships.
