

# MAKING BENEFICIAL LIFESTYLE CHOICES

wenty-two Scott Countians enrolled in our physical activity and education program using the "Get Moving Kentucky" curriculum. Twelve completed the eight-week program, attended the organized learning sessions and turned in paperwork. In addition, they completed 1,825 Physical Activity Miles (PAM) over the eight-week period. Each PAM represents 15 minutes of activity. One hundred percent of the 12 participants who completed the project indicated that the program encouraged them to start exercising or increase the amount of exercise they were already getting. They also indicated increased energy, reduced stress and less "sitting." Success stories showed isolated cases of weight loss, stabilized weight, lower blood pressure, increased

energy, lower blood sugar, better nutrition, more flexibility and lower cholesterol. Georgetown/Scott County Parks and Recreation partnered with Extension in this effort.<sup>1</sup>





#### **OUR COMMUNITY**

► Unemployment rates are a key economic indicator. In August 2009, the rate of unemployment in Scott County was 10.1%.<sup>3</sup>

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Scott County,


- 60 people were involved in addressing issues of their community.
- 410 people increased their knowledge of governmental process.
- 16 people expanded their knowledge of economic development.

**3.08%** of mortgages are 90-days delinquent and 60-day bank card delinquency rates have increased by **1.43%**.<sup>4</sup> In a one-year period (October 2008 through October 2009), **266** foreclosures were filed.<sup>5</sup>

Access to health insurance is another important factor contributing to family well-being. In Scott County, **13%** of the people under age 65 are uninsured.<sup>6</sup>

### **OUR HEALTH**

► The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Scott County. *Figure 2. Health Risks.*<sup>6</sup>




### As a result of participation in Scott County Extension programs:<sup>1</sup>

- **695** people increased knowledge of practices to maintain health and well-being.
- **615** people increase knowledge of safe practices to store, handle, and prepare food.
- 250 people developed skills to access affordable food.

#### **OUR FAMILIES**

- ▶ Using data from the 2000 U.S. Census, Scott County families can be described as follows:<sup>2</sup>
- 8,990 families reside in the county.
- 657 families (7.3%) live below poverty level.
- Median family income is \$54,117.
- **222** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, 1,998 people in Scott County receive food stamps. The average family food stamp benefit is \$254.95 per month.<sup>7</sup>

In the county, **93** children live in out-of-home care.<sup>8</sup>

In 2005, there were **176** incidents of adult abuse and **75** incidents of child abuse.<sup>9</sup>

## As a result of participation in Scott County Extension programs:<sup>1</sup>

- 90 adults and youth improved their ability to make informed and effective decisions.
- 18 people adopted money management practices to reduce debt and/or increase savings.
- 10 people increased their knowledge and skills related to parenting and personal relationships.
