

MAKING BENEFICIAL LIFESTYLE CHOICES

rimble County Extension found evidence that reading books that focus on preparing and eating healthy foods and being physically active may motivate children to adopt positive food and physical activity behaviors. With that in mind, we collaborated with Trimble County schools to offer the "Literacy, Eating and Activity for Preschools" to approximately 70 preschoolers. The Family and Consumer Sciences agent, along with local volunteers, read stories twice a month that introduced nutritious foods, concepts of staying healthy and physical activity. As a result of the program, students showed increased participation in physical activity, were more inclined to taste unfamiliar fruits and vegetables, and

were more apt to eat fruits and vegetables at mealtime. Parents were also informed about the importance of proper nutrition and physical activity via newsletters sent home.¹





OUR COMMUNITY

► Unemployment rates are a key economic indicator. In August 2009, the rate of unemployment in Trimble County was 11.9%.³

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community wellbeing. In Trimble County, **1.77%** of


- 77 people were involved in addressing issues of their community.
- 26 people increased their knowledge of governmental process.
- 52 people expanded their knowledge of economic development.

mortgages are 90-days delinquent and 60-day bank card delinquency rates have increased by **1.93%**. In a one-year period (October 2008 through October 2009), **29** foreclosures were filed.

Access to health insurance is another important factor contributing to family well-being. In Trimble County, **14%** of the people under age 65 are uninsured.⁶

OUR HEALTH

▶ The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Trimble County. *Figure 2. Health Risks.*⁶




As a result of participation in Trimble County Extension programs:¹

- 138 people increased knowledge of practices to maintain health and well-being.
- 116 people increase knowledge of safe practices to store, handle, and prepare food.
- 27 people developed skills to access affordable food.

OUR FAMILIES

- ► Using data from the 2000 U.S. Census, Trimble County families can be described as follows:²
- 2,297 families reside in the county.
- 231 families (10%) live below poverty level.
- Median family income is \$41,925.
- **126** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **537** people in Trimble County receive food stamps. The average family food stamp benefit is **\$235.02** per month.⁷

In the county, **6** children live in out-of-home care.⁸

In 2005, there were **26** incidents of adult abuse and **26** incidents of child abuse.⁹

As a result of participation in Trimble County Extension programs:¹

- 125 adults and youth improved their ability to make informed and effective decisions.
- **300** adults and youth improved practical living skills.
