



MAKING BENEFICIAL LIFESTYLE CHOICES

ashington County is plagued by high rates of obesity and low levels of physical activity among adults. It is our goal to address this problem through educational programs encouraging healthy lifestyle changes. One such program is "Weigh Down Washington County,' now in its seventh year. This program is designed to help participants lose weight and to encourage some type of physical activity. The FCS agent, with assistance from the local health department, area health department, the Nutrition Education Program assistant and the community education director, worked with 79 participants

who were challenged to lose 7 percent of their body weight. The entire group lost a combined total of 325.5 pounds. Weigh Down was widely publicized in newspapers, news letter, and church bulletins as well as on radio programs.¹





OUR COMMUNITY

► Unemployment rates are a key economic indicator. In August 2009, the rate of unemployment in Washington County was 13.2%.³

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community wellbeing. In Washington

As a result of participation in Washington County Extension programs:¹


- 483 people were involved in addressing issues of their community.
- 132 people increased their knowledge of governmental process.
- 215 people expanded their knowledge of economic development.

County, **4.14%** of mortgages are 90-days delinquent and 60-day bank card delinquency rates have increased by **1.73%**.⁴ In a one-year period (October 2008 through October 2009), **22** foreclosures were filed.⁵

Access to health insurance is another important factor contributing to family well-being. In Washington County, **13%** of the people under age 65 are uninsured.⁶

OUR HEALTH

► The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Washington County. *Figure 2. Health Risks.*⁶




As a result of participation in Washington County Extension programs:¹

- **450** people increased knowledge of practices to maintain health and well-being.
- **525** people used safe practices to store, handle, and prepare food.
- **360** people developed skills to access affordable food.

OUR FAMILIES

- ▶ Using data from the 2000 U.S. Census, Washington County families can be described as follows:²
- 3,020 families reside in the county.
- 310 families (10.3%) live below poverty level.
- Median family income is \$39,240.
- 88 grandparents are responsible for the care

of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **581** people in Washington County receive food stamps. The average family food stamp benefit is **\$201.72** per month.⁷

In the county,

10 children live in out-of-home care.⁸ In 2005, there were **16** incidents of adult abuse and **32** incidents of child abuse.⁹

As a result of participation in Washington County Extension programs:¹

- 842 adults and youth improved their ability to make informed and effective decisions.
- 320 people adopted money management practices to reduce debt and/or increase savings.
- 72 people increased their knowledge and skills related to parenting and personal relationships.
