



SECURING FINANCIAL STABILITY

any Whitley County residents experience issues related to their health and personal finances. Sixty-four percent are overweight and more than half live "paycheck to paycheck." As a result, the Whitley County Family and Consumer Sciences agent offered "Small Steps to Health and Wealth," a 12-week program that promotes behavior change strategies for health and wealth. Seventy-four participants were given survival tool kits that included pedometers, pocket calorie-counter books and "Nutrition in the Fast Lane" books. Progress indicators, participant journals and weekly weigh-ins revealed that 64 percent of participants added 30 min-

utes of physical activity to their daily routine, 76 percent lost 10 percent or more of body weight, 74 percent increased their daily intake of water and fruits and vegetables, and 56 percent created a savings plan.¹





OUR COMMUNITY

► Unemployment rates are a key economic indicator. In August 2009, the rate of unemployment in Whitley County was 12.1%.3

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community wellbeing. In Whitley

As a result of participation in Whitley County Extension programs:¹


- 130 people were involved in addressing issues of their community.
- 400 people increased their knowledge of governmental process.
- **35** people were prepared to enter the work force.

County, **1.40%** of mortgages are 90-days delinquent and 60-day bank card delinquency rates have increased by **2.40%**.⁴ In a one-year period (October 2008 through October 2009), **124** foreclosures were filed.⁵

Access to health insurance is another important factor contributing to family well-being. In Whitley County, **19%** of the people under age 65 are uninsured.⁶

OUR HEALTH

► The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Whitley County. *Figure 2. Health Risks.*⁶




As a result of participation in Whitley County Extension programs:¹

- **650** people increased knowledge of practices to maintain health and well-being.
- **500** people developed skills to access affordable food.
- **1,000** people increased their use of radon testers, smoke detectors, fire extinguishers, and other devices to ensure personal safety.

OUR FAMILIES

- ► Using data from the 2000 U.S. Census, Whitley County families can be described as follows:²
- 9,888 families reside in the county.
- 2,163 families (21.6%) live below poverty level.
- Median family income is \$27,871.
- **390** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **4,349** people in Whitley County receive food stamps. The average family food stamp benefit is **\$220.61** per month.⁷

In the county, 275 children live in out-of-home care.8

In 2005, there were **90** incidents of adult abuse and **215** incidents of child abuse.⁹

As a result of participation in Whitley County Extension programs:¹

- 360 adults and youth improved their ability to make informed and effective decisions.
- 46 people increased their knowledge and skills related to parenting and personal relationships.
- **80** adults and youth improved practical living skills.
