



Figure 1. Population by Age Group² (n=17,773)





ACCESSING NUTRITIOUS FOOD

ightened budgets have resulted in increased gardening, canning, freezing, and other methods of long-term storage. Family and Consumer Sciences Agents conducted a workshop to teach the value and safety of food preservation. Freezing, drying, water-bath and pressure-canning techniques were taught in two half-day sessions. Eighty percent of participants stated that they were confident that they could repeat the skills learned in the workshops. After the sessions last season, 15 of the 23 partici-

pants returned evaluation forms reporting safely canning 415 quarts of produce and freezing 165 quarts. By popular demand two more sessions were taught in the summer of 2010, reaching twenty novice or first time food preservationists.1





OUR COMMUNITY

Dunemployment rates are a key economic indicator. In July 2010, the rate of unemployment in Adair County was **10.2%**.6

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Adair County, **2.9%** of mortgages are 90-days delinquent and **1.0%** of bank cards

As a result of participation in Adair County Extension programs:¹


- 424 people increased their knowledge of governmental process.
- **5** people were prepared to enter the work force.
- 300 people expanded their knowledge of economic development.
- Adair County Extension is involved in 30 community coalitions.

are 60-days delinquent.⁷ In a one-year period (August 2009 through August 2010), **21** foreclosures were filed.⁵

Access to health insurance is another important factor contributing to family well-being. In Adair County, **21%** of the people under age 65 are uninsured.⁸

OUR HEALTH

➤ The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Adair County. *Figure 2. Health Risks.*⁸

As a result of participation in Adair County Extension programs:

- **300** people used safe practices to store, handle, and prepare food.
- 800 people made lifestyle changes to improve health
- **650** people increased their use of radon testers, smoke detectors, fire extinguishers, and other devices to ensure personal safety.

OUR FAMILIES

- ▶ Using data from the 2000 U.S. Census, Adair County families can be described as follows:²
- 4,801 families reside in the county.
- 870 families (18.2%) live below poverty level.
- Median family income is \$29,779.
- **180** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, 1,332 people in Adair County receive supplemental nutrition assistance. The average family benefit is \$219.62 per month.³

In the county, **31** children live in out-of-home care. There were **54**

child victims of substantiated abuse.⁴ There were **34** incidents of adult abuse.⁵

As a result of participation in Adair County Extension programs:¹

- 500 people adopted money management practices to reduce debt and/or increase savings.
- 240 people increased their knowledge and skills related to parenting and personal relationships.
- 1,205 adults and youth improved practical living skills.
