

Figure 1. Population by Age Group<sup>2</sup> (n=21,347)



besity and inactivity rates are at all-time highs in the U.S., and the obesity rate in Kentucky is one of the highest in the nation (CDC). To address these issues in our community, the Anderson County Cooperative Extension Service with local sponsors implemented Second Sunday. This program emphasizes physical activity by closing a neighborhood street to traffic and opening the street to local residents. The event takes place the second Sunday in October across the Common-

wealth. Anderson County residents celebrated by walking, riding bikes, and other activities on Main Street. One hundred and five participants enjoyed the physical activity break with no traffic during the event.1





#### **OUR COMMUNITY**

► Unemployment rates are a key economic indicator. In July 2010, the rate of unemployment in Anderson County was **10.6%**.6

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Anderson County, **3.5%** of mortgages are 90-days delinquent

### As a result of participation in Anderson County Extension programs:


- 31 people were involved in addressing issues of their community.
- 6 people increased their knowledge of governmental process.
- 8 people expanded their knowledge of economic development.

and **1.6%** of bank cards are 60-days delinquent.<sup>7</sup> In a oneyear period (August 2009 through August 2010), **157** foreclosures were filed.<sup>5</sup>

Access to health insurance is another important factor contributing to family well-being. In Anderson County, **9%** of the people under age 65 are uninsured.8

### **OUR HEALTH**

➤ The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Anderson County. *Figure 2. Health Risks.*\*



### As a result of participation in Anderson County Extension programs:<sup>1</sup>

- **578** people increased knowledge of practices to maintain health and well-being.
- **44** people increased knowledge of safe practices to store, handle, and prepare food.
- 36 people developed skills to access affordable food.

#### **OUR FAMILIES**

- ▶ Using data from the 2000 U.S. Census, Anderson County families can be described as follows:²
- 5,526 families reside in the county.
- 267 families (4.8%) live below poverty level.
- Median family income is \$50,837.
- 77 grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **881** people in Anderson County receive supplemental nutrition assistance. The average family benefit is **\$283.54** per month.<sup>3</sup>

In the county, **69** children live in out-of-home care. There were **120** 

child victims of substantiated abuse.<sup>4</sup> There were **40** incidents of adult abuse.<sup>5</sup>

### As a result of participation in Anderson County Extension programs:<sup>1</sup>

- 935 adults and youth improved their ability to make informed and effective decisions.
- 65 people adopted money management practices to reduce debt and/or increase savings.
- **535** adults and youth improved practical living skills.
