

➤ 2008 estimates from the 2000 U.S. Census reported total population as **29,055**.<sup>2</sup> The graph on the right indicates the percentage



# MAKING BENEFICIAL LIFESTYLE CHOICES

By using LEAP curriculum, the Extension Office, with Family Resource Centers and several school teachers, reached 400 students in pre-school through second grade with critical educational information. The FCS Agent and FSNEP assistants visited six schools, reading stories that encouraged physical fitness, proper oral health, correct hand washing, and healthy eating. Children listened and participated in hands-on activity relating to the book. All students gained knowledge on hand washing and tooth brushing. Teachers reported that 85%

of the children aspired to incorporate more physical activity in their school day. One teacher stated, "My class loves to dance and get moving because of your story and the zumba dance that you did with them."1

#### **OUR COMMUNITY**

► Unemployment rates are a key economic indicator. In July 2010, the rate of unemployment in Bell County was 12.1%.6

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Bell County, 1.9% of mortgages are 90-days delinquent and 1.6% of bank cards are 60-days delin-


- 501 people were involved in addressing issues in their community.

- 278 people expanded their knowledge of economic development.

quent.<sup>7</sup> In a one-year period (August 2009 through August 2010), **80** foreclosures were filed.<sup>5</sup>

Access to health insurance is another important factor contributing to family well-being. In Bell County, **13%** of the people under age 65 are uninsured.<sup>8</sup>

### **OUR HEALTH**

➤ The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Bell County. *Figure 2. Health Risks.*\*



### As a result of participation in Bell County Extension programs:<sup>1</sup>

- **702** people increased knowledge of practices to maintain health and well-being.
- **431** people increased knowledge of safe practices to store, handle, and prepare food.
- 270 people made lifestyle changes to improve health.

### **OUR FAMILIES**

- ▶ Using data from the 2000 U.S. Census, Bell County families can be described as follows:²
- 8,522 families reside in the county.
- 2,295 families (26.7%) live below poverty level.
- Median family income is \$23,818.
- 277 grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **4,375** people in Bell County receive supplemental nutrition assistance. The average family benefit is **\$232.21** per month.<sup>3</sup>

In the county, 44 children live in out-of-home care. There were 121

child victims of substantiated abuse.<sup>4</sup> There were **131** incidents of adult abuse.<sup>5</sup>

### As a result of participation in Bell County Extension programs:<sup>1</sup>

- 1,192 adults and youth improved their ability to make informed and effective decisions.
- **1,089** people increased their knowledge and skills related to parenting and personal relationships.
- **536** adults and youth improved practical living skills.
