

➤ 2008 estimates from the 2000 U.S. Census reported total population as 19,828.² The graph on the right indicates the percentage




SPOTLIGHT ON...

PROMOTING HEALTHY HOMES AND COMMUNITIES

Wellness Coalition, led by Bourbon County Extension and community partners, sought significant funding to foster health and wellness. A \$30,000 grant was awarded to promote community gardens, smoking cessation, nutrition in schools, and built-environment (trails and skateboard) parks. A \$60,000 grant was awarded to further policy change in those areas. In addition, Get Fit Bourbon County enrolled 25 people, with the goal of fostering behaviors that could lead to weight loss. Of the 17 people completing it, 100% stated they were exer-

cising and/or walking more; they were better informed about healthier eating; they were more likely to make better lifestyle choices concerning health; and they had an increased understanding of how stress affects health.1

OUR COMMUNITY

► Unemployment rates are a key economic indicator. In July 2010, the rate of unemployment in Bourbon County was 9.2%.

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Bourbon County, **4.0%** of mortgages are 90-days delinquent and **1.4%** of bank cards are 60-days delin-


- 379 people were involved in addressing issues in their community
- 390 people increased their knowledge of governmental process.
- 70 people expanded their knowledge of economic development.
- Bourbon County Extension is involved in 10 community coalitions.

quent.⁷ In a one-year period (August 2009 through August 2010), **103** foreclosures were filed.⁵

Access to health insurance is another important factor contributing to family well-being. In Bourbon County, **14%** of the people under age 65 are uninsured.8

OUR HEALTH

➤ The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Bourbon County. *Figure 2. Health Risks.*⁸



As a result of participation in Bourbon County Extension programs:¹

- **2,050** people increased knowledge of practices to maintain health and well-being.
- 1,100 people used safe practices to store, handle, and prepare food.
- 800 people made lifestyle changes to improve health.

OUR FAMILIES

- ► Using data from the 2000 U.S. Census, Bourbon County families can be described as follows:²
- 5,448 families reside in the county.
- 679 families (12.3%) live below poverty level.
- Median family income is \$42,294.
- 175 grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **1,210** people in Bourbon County receive supplemental nutrition assistance. The average family benefit is **\$259.84** per month.³

In the county, **37** children live in out-of-home care. There were **57**

child victims of substantiated abuse.⁴ There were **48** incidents of adult abuse.⁵

As a result of participation in Bourbon County Extension programs:¹

- 250 adults and youth improved their ability to make informed and effective decisions.
- 45 people adopted money management practices to reduce debt and/or increase savings.
- **1,300** adults and youth improved practical living skills.
