



PROMOTING HEALTHY HOMES AND COMMUNITIES

entucky ranks seventh-highest in the nation for adult obesity; Kentucky children have the fourth-highest rate of childhood obesity in the country. The Centers for Disease Control reports that Kentucky leads the nation with 28.4% inactive adults, compared to 16% nationally. To address the need for safe physical activity, Extension joined counties across the state for Second Sunday. To stimulate fun, easy physical activity, streets were closed for a one-mile walk and four hours of activities, including jumping rope, hula hoops, sack races, yoga, zumba,

karate, and competitions. The FCS Agent coordinated the effort with community partners and volunteers. As a result of the program, local residents continue to challenge the community to be active throughout the year.1





OUR COMMUNITY

► Unemployment rates are a key economic indicator. In July 2010, the rate of unemployment in Carroll County was **12.5%**.6

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Carroll County, 1.8% of mortgages are 90-days delinquent and 2.1% of bank cards are 60-days delin-


- 200 people involved in addressing issues of the community.
- 30 people increased their knowledge of governmental process.
- 45 people expanded their knowledge of economic development.
- Carroll County Extension is involved in 18 community coalitions.

quent.⁷ In a one-year period (August 2009 through August 2010), **47** foreclosures were filed.⁵

Access to health insurance is another important factor contributing to family well-being. In Carroll County, **15%** of the people under age 65 are uninsured.⁸

OUR HEALTH

► The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Carroll County. *Figure 2. Health Risks.**



As a result of participation in Carroll County Extension programs:¹

- **1,500** people increased knowledge of practices to maintain health and well-being.
- **890** people increased knowledge of safe practices to store, handle, and prepare food.
- 575 people made lifestyle changes to improve health.

OUR FAMILIES

- ► Using data from the 2000 U.S. Census, Carroll County families can be described as follows:²
- 2,723 families reside in the county.
- 290 families (10.4%) live below poverty level.
- Median family income is \$44,037.
- **193** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **831** people in Carroll County receive supplemental nutrition assistance. The average family benefit is **\$268.75** per month.³

In the county, 11 children live in out-of-home care. There were 46

child victims of substantiated abuse.⁴ There were **64** incidents of adult abuse.⁵

As a result of participation in Carroll County Extension programs:¹

- 468 adults and youth improved their ability to make informed and effective decisions.
- 40 people increased their knowledge and skills related to parenting and personal relationships.
- **625** adults and youth improved practical living skills.
