

Figure 1. Population by Age Group² (n=9,244)




SPOTLIGHT ON...

ACCESSING NUTRITIOUS FOOD

he goal of the Extension Food and Nutrition Education Program (EFNEP) is to teach limited-resource families with young children to plan nutritious meals on a limited budget, acquire safe food handling practices, improve food preparation skills, and change behavior to have a healthy lifestyle. Crittenden County Extension EFNEP paraprofessional worked with 81 limited-resource families, graduating 45 families after 6-15 months. Forty-one percent of those graduating reported improvements in the nutritional quality of their diets, while 42% consumed a diet of higher quality because they

planned meals using My-Pyramid and nutrition facts on labels; 36% began feeding their children breakfast and 31% reported increased frequency of moderate physical activity for 30 minutes per day.¹





OUR COMMUNITY

► Unemployment rates are a key economic indicator. In July 2010, the rate of unemployment in Crittenden County was 9.8%.6

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Crittenden County, **0.5%** of mortgages are 90-days delinquent and **1.2%** of bank cards are 60-days delin-


- 72 people were involved in addressing issues in their community.
- 92 people increased their knowledge of governmental process.
- 5 people expanded their knowledge of economic development.
- Crittenden County Extension is involved in 4 community coalitions.

quent.⁷ In a one-year period (August 2009 through August 2010), **11** foreclosures were filed.⁵

Access to health insurance is another important factor contributing to family well-being. In Crittenden County, **15**% of the people under age 65 are uninsured.⁸

OUR HEALTH

➤ The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Crittenden County. *Figure 2. Health Risks.**

As a result of participation in Crittenden County Extension programs:¹

- 97 people increased knowledge of practices to maintain health and well-being.
- **192** people used safe practices to store, handle, and prepare food.
- 131 people made lifestyle changes to improve health.

OUR FAMILIES

- ▶ Using data from the 2000 U.S. Census, Crittenden County families can be described as follows:²
- 2,706 families reside in the county.
- 405 families (14.7%) live below poverty level.
- Median family income is \$36,462.
- **99** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **530** people in Crittenden County receive supplemental nutrition assistance. The average family benefit is **\$222.16** per month.³

In the county, **15** children live in out-of-home care. There were **56**

child victims of substantiated abuse.⁴ There were **37** incidents of adult abuse.⁵

As a result of participation in Crittenden County Extension programs:¹

- 120 adults and youth improved their ability to make informed and effective decisions.
- 31 people adopted money management practices to reduce debt and/or increase savings.
- **39** people increased their knowledge and skills related to parenting and personal relationships.
