



Figure 1. Population by Age Group<sup>2</sup> (n=14,792)





# PROMOTING HEALTHY HOMES AND COMMUNITIES

arrard County is increasing the number of planned exercise opportunities with a new hiking trail. Supported by efforts of the Extension Office, the trail opened in fall 2010. Working with the County Judge, fiscal court, city council, and others, Extension has committed up to \$20,000 to create signage for environmental education and information about physical activity along the footpath. With financial partners in the community, Family & Consumer Sciences will enhance physical activity opportunities on the trail. After two years in other

locations, the state-wide Second Sunday events took place at the new trail. The newly opened trail will mark the increase in much needed builtenvironment opportunities in Garrard County.1





### **OUR COMMUNITY**

► Unemployment rates are a key economic indicator. In July 2010, the rate of unemployment in Garrard County was **11.0%**.6

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Garrard County, **4.0%** of mortgages are 90-days delinquent and **1.0%** of bank cards


- 15 people were involved in addressing issues of their community.

are 60-days delinquent.<sup>7</sup> In a one-year period (August 2009 through August 2010), **130** foreclosures were filed.<sup>5</sup>

Access to health insurance is another important factor contributing to family well-being. In Garrard County, **14%** of the people under age 65 are uninsured.<sup>8</sup>

### **OUR HEALTH**

► The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Garrard County. *Figure 2. Health Risks.*\*



### As a result of participation in Garrard County Extension programs:<sup>1</sup>

- 25 people implemented new practices to maintain health and well-being.
- **30** people used safe practices to store, handle, and prepare food.
- 10 people developed skills to access affordable food.

### **OUR FAMILIES**

- ► Using data from the 2000 U.S. Census, Garrard County families can be described as follows:<sup>2</sup>
- 4,336 families reside in the county.
- 506 families (11.6%) live below poverty level.
- Median family income is \$41,250.
- **100** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **1,205** people in Garrard County receive supplemental nutrition assistance. The average family benefit is **\$258.72** per month.<sup>3</sup>

In the county, **66** children live in out-of-home care. There were **91** 

child victims of substantiated abuse.<sup>4</sup> There were **30** incidents of adult abuse.<sup>5</sup>

### As a result of participation in Garrard County Extension programs:<sup>1</sup>

- **35** adults and youth improved their ability to make informed and effective decisions.
- 5 people increased their knowledge and skills related to parenting and personal relationships.
- 15 adults and youth improved practical living skills.
