
► Family and Consumer Sciences Extension is committed to improving the quality of life for individuals and families in Kentucky. Educational programs focus on:



FEATURED PROGRAMS

uring 2009 – 2010, Family and Consumer Sciences Extension collected detailed impact data for three specific programs. The following outcomes were documented through these programs.¹

- 40% of participants in "Weight the Reality Series Body Image" succeeded in losing 5% of their initial weight during the program.
- 78% of children who participated in "LEAP Literacy, Eating, and Activity for Preschool" increased their level of physical activity.
- 25% of participants in "Small Steps to Health and Wealth" decreased their expenses as a result of the program.





OUR COMMUNITY

► Unemployment rates are a key economic indicator. In July 2010, the rate of unemployment in Kentucky was **10.0%**.6

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Kentucky, **2.6%** of mortgages are 90-days delinquent and **1.7%** of bank cards

As a result of participation in Kentucky Extension programs:¹


- 31,107 people were involved in addressing issues of their community.
- **12,903** people were prepared to enter the work force.
- 23,989 people expanded their knowledge of economic development.
- Cooperative Extension is involved in 3,086 community coalitions.

are 60-days delinquent.⁷ In a one-year period (August 2009 through August 2010), **19,969** foreclosures were filed.⁵

Access to health insurance is another important factor contributing to family well-being. In Kentucky, **14%** of the people under age 65 are uninsured.⁸

OUR HEALTH

➤ The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Kentucky. *Figure 2. Health Risks.*⁸

As a result of participation in Kentucky Extension programs:¹

- **195,760** people increased knowledge of practices to maintain health and well-being.
- **78,563** people increase knowledge of safe practices to store, handle, and prepare food.
- **35,402** people developed skills to access affordable food.

OUR FAMILIES

- ▶ Using data from the 2000 U.S. Census, Kentucky families can be described as follows:²
- 1,110,426 families reside in the state.
- 140,519 families (12.7%) live below poverty level.
- Median family income is \$40,939.
- **35,818** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **306,491** people in Kentucky receive supplemental nutrition assistance. The average family benefit is **\$242.53** per month.³

In the state, 12,971 children live in outof-home care. There were 7,583 child victims of sub-

stantiated abuse.⁴ There were **13,916** incidents of adult abuse.⁵

As a result of participation in Kentucky Extension programs:¹

- 95,939 adults and youth improved their ability to make informed and effective decisions.
- 28,016 people adopted money management practices to reduce debt and/or increase savings.
- 24,898 people increased their knowledge and skills related to parenting and personal relationships.
