

### **OUR COMMUNITY**

► Unemployment rates are a key economic indicator. In July 2010, the rate of unemployment in Knott County was **11.6%**.6

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Knott County, **3.4%** of mortgages are 90-days delinquent and **1.9%** of bank cards are 60-days delin-


- 264 people were involved in addressing issues of their community.

quent.<sup>7</sup> In a one-year period (August 2009 through August 2010), **22** foreclosures were filed.<sup>5</sup>

Access to health insurance is another important factor contributing to family well-being. In Knott County, **17%** of the people under age 65 are uninsured.<sup>8</sup>

### **OUR HEALTH**

➤ The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Knott County. *Figure 2. Health Risks.*\*



### As a result of participation in Knott County Extension programs:<sup>1</sup>

- 914 people implemented new practices to maintain health and well-being.
- **956** people increased their knowledge and skills related to parenting and personal relationships.
- **568** people developed skills to access affordable food.

### **OUR FAMILIES**

- ► Using data from the 2000 U.S. Census, Knott County families can be described as follows:<sup>2</sup>
- 4,992 families reside in the county.
- 1,313 families (26.2%) live below poverty level.
- Median family income is \$24,930.
- **122** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **2,357** people in Knott County receive supplemental nutrition assistance. The average family benefit is **\$219.65** per month.<sup>3</sup>

In the county, **47** children live in out-of-home care. There were **99** 

child victims of substantiated abuse.<sup>4</sup> There were **42** incidents of adult abuse.<sup>5</sup>

### As a result of participation in Knott County Extension programs:<sup>1</sup>

- 1,751 adults and youth improved their ability to make informed and effective decisions.
- 488 people increased their knowledge and skills related to parenting and personal relationships.
- 2,194 adults and youth improved practical living skills.
