
Family and Consumer Sciences Extension made **1,912** contacts with Knox County families during 2009-2010.¹

ACCESSING NUTRITIOUS FOOD

conomic stressors on family budgets have resulted in an increase in home gardening and food preservation. To address food preservation safety issues, Knox County Family and Consumer Sciences Extension Agent implemented a Food Preservation Boot Camp. Twenty-six participants learned about and participated in proper food-preservation techniques utilizing canning, freezing, and drying. A survey was conducted to ensure food-safety practices were understood. All participants could identify the bacteria of concern in canning-clostridium

botulinum. Seventyfive percent became more familiar with using a pressure canner, and 80 percent learned proper canning procedures. Safe, affordable food resources, such as home gardening and other food preservation information, were provided to help ease the stress on family food budgets.1





OUR COMMUNITY

► Unemployment rates are a key economic indicator. In July 2010, the rate of unemployment in Knox County was **10.8%**.6

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Knox County, **3.2%** of mortgages are 90-days delinquent and **2.6%** of bank cards

As a result of participation in Knox County Extension programs:¹


- 100 people were involved in addressing issues of their community.
- **125** people were prepared to enter the work force.
- 55 people expanded their knowledge of economic development.
- Knox County Extension is involved in 35 community coalitions.

are 60-days delinquent.⁷ In a one-year period (August 2009 through August 2010), **64** foreclosures were filed.⁵

Access to health insurance is another important factor contributing to family well-being. In Knox County, **21%** of the people under age 65 are uninsured.⁸

OUR HEALTH

➤ The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Knox County. *Figure 2. Health Risks.*⁸

As a result of participation in Knox County Extension programs:

- **3,000** people increased knowledge of practices to maintain health and well-being.
- **1,500** people increased knowledge of safe practices to store, handle, and prepare food.
- **200** people developed skills to access affordable food.

OUR FAMILIES

- ► Using data from the 2000 U.S. Census, Knox County families can be described as follows:²
- 8,936 families reside in the county.
- 2,630 families (29.6%) live below poverty level.
- Median family income is \$23,136.
- **435** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **5,005** people in Knox County receive supplemental nutrition assistance. The average family benefit is **\$238.42** per month.³

In the county, 78 children live in out-of-home care. There were 101

child victims of substantiated abuse.⁴ There were **134** incidents of adult abuse.⁵

As a result of participation in Knox County Extension programs:¹

- 1,400 adults and youth improved their ability to make informed and effective decisions.
- 300 people adopted money management practices to reduce debt and/or increase savings.
- **2,200** adults and youth improved practical living skills.
