

2008 estimates from the 2000 U.S. Census reported total population as 13,373.² The graph on the right indicates the percentage by age group.




SPOTLIGHT ON...

PROMOTING HEALTHY HOMES AND COMMUNITIES

he LaRue Family and Consumer Sciences Agent presented "Greening Your Home" to 57 Extension Homemaker leaders. After the class, these leaders gave feedback on changes or actions they plan to make: 25 will start using a reusable shopping bag; 19 will use a green product even though it may cost more; 25 will buy green cleaning products; 20 will schedule a home energy audit with their utility provider; and 13 will enroll with their home util-

ity provider's remote switch energy management program, which pays for participation or provides savings on energy bills. The leaders reported that they shared the class information with 742 other persons in the community.1





OUR COMMUNITY

Unemployment rates are a key economic indicator. In July 2010, the rate of unemployment in LaRue County was 9.7%.⁶

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In LaRue County, **3.2%** of mortgages are 90-days delinquent and **1.7%** of bank cards are 60-days delin-


- **170** people were involved in addressing issues of their community.
- **160** people increased their knowledge of governmental process.
- **333** people expanded their knowledge of economic development.
- LaRue County Extension is involved in **21** community coalitions.

quent.⁷ In a one-year period (August 2009 through August 2010), **5** foreclosures were filed.⁵

Access to health insurance is another important factor contributing to family well-being. In LaRue County, **13%** of the people under age 65 are uninsured.⁸

OUR HEALTH

► The health of our people contributes to quality of life. The chart below illustrates health risks of adults in LaRue County. *Figure 2. Health Risks.*[®]



As a result of participation in LaRue County Extension programs:¹

- **330** people increased knowledge of practices to maintain health and well-being.
- **212** people increased knowledge of safe practices to store, handle, and prepare food.
- 260 people made lifestyle changes to improve health.

OUR FAMILIES

- ► Using data from the 2000 U.S. Census, LaRue County families can be described as follows:²
- 3,866 families reside in the county.
- 487 families (12.6%) live below poverty level.
- Median family income is \$37,786.
- **103** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **997** people in LaRue County receive supplemental nutrition assistance. The average family benefit is **\$242.89** per month.³

In the county, **36** children live in out-of-home care. There were **98**

child victims of substantiated abuse.⁴ There were **42** incidents of adult abuse.⁵

As a result of participation in LaRue County Extension programs:¹

- **230** adults and youth improved their ability to make informed and effective decisions.
- **85** people adopted money management practices to reduce debt and/or increase savings.
- **311** adults and youth improved practical living skills.
