

▶ 2008 estimates and over from the 2000 U.S. Census reported total population as **30,125**.² The graph on




SPOTLIGHT ON...

EMPOWERING COMMUNITY LEADERS

arshall County Homemakers provide a support network and recognizable leadership. Members learn far-reaching teaching strategies through monthly learning sessions and club meetings. Leaders then teach hands-on programs in parenting, literacy, health, clothing, home environment, and household management. The Family Literacy program has benefited from \$6500 in books and reading resources given by Extension Homemakers to the Marshall County Pre-School Head Start program over the past nine years. As a result, families report increased reading activities in homes

and schools. At the Homemakers' state meeting, Marshall County Homemakers were recognized for contributing more than 154,017 hours in teaching activities and community service over the past two years, valued at over \$3,000,000 (\$20.85 an hour).1

OUR COMMUNITY

► Unemployment rates are a key economic indicator. In July 2010, the rate of unemployment in Marshall County was **10.0%**.6

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Marshall County, 1.2% of mortgages are 90-days delinquent and 1.0% of bank cards are 60-days delin-


- 71 people were involved in addressing issues of their community.
- 188 people increased their knowledge of governmental process.
- 550 people expanded their knowledge of economic development.
- Marshall County Extension is involved in 8 community coalitions.

quent.⁷ In a one-year period (August 2009 through August 2010), **127** foreclosures were filed.⁵

Access to health insurance is another important factor contributing to family well-being. In Marshall County, **11%** of the people under age 65 are uninsured.⁸

OUR HEALTH

➤ The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Marshall County. *Figure 2. Health Risks.**



As a result of participation in Marshall County Extension programs:¹

- 713 people increased knowledge of practices to maintain health and well-being.
- **120** people increased knowledge of safe practices to store, handle, and prepare food.
- 35 people made lifestyle changes to improve health.

OUR FAMILIES

- ▶ Using data from the 2000 U.S. Census, Marshall County families can be described as follows:²
- 8,993 families reside in the county.
- 593 families (6.6%) live below poverty level.
- Median family income is \$43,670.
- **282** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **1,554** people in Marshall County receive supplemental nutrition assistance. The average family benefit is **\$233.06** per month.³

In the county, **90** children live in out-of-home care. There were **68**

child victims of substantiated abuse.⁴ There were **84** incidents of adult abuse.⁵

As a result of participation in Marshall County Extension programs:¹

- 601 adults and youth improved their ability to make informed and effective decisions.
- 124 people increased their knowledge and skills related to parenting and personal relationships.
- 488 adults and youth improved practical living skills.
