### OUR FOCUS

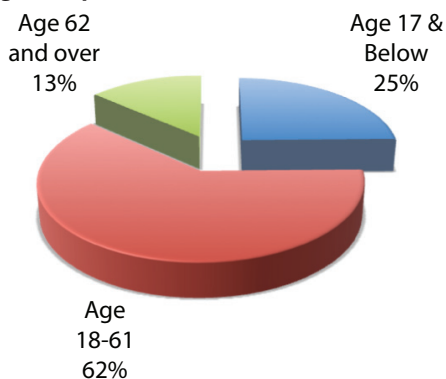

Family and Consumer Sciences Extension made **30,628** contacts with Montgomery County families during 2009-2010.<sup>1</sup>

## PROMOTING HEALTHY HOMES AND COMMUNITIES

Our world contains finite resources, and with wise use we can extend availability and have a more sustainable environment. A program based on University of Kentucky's "Living Green: A Matter of Choice" was taught in 19 Kentucky counties to 124 Homemakers. These leaders shared the lesson concepts to 1485 members. A post survey sent to the trained homemaker leaders indicated that 65 participants now use CFL or LED bulb, 71 are unplugging unused appliances, 35 opted out of receiving junk mail and they have encouraged 703 additional people to adopt greener lifestyles. Green household and consumer products were used to illustrate innovative options in a tabletop display for educational shows, reaching an additional 4,000 people.<sup>1</sup>



## OUR COMMUNITY

► Unemployment rates are a key economic indicator. In July 2010, the rate of unemployment in Montgomery County was **11.6%**.<sup>6</sup>

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Montgomery County, **3.4%** of mortgages are 90-days delinquent and **1.7%** of bank cards are 60-days delinquent.<sup>7</sup> In a one-year period (August 2009 through August 2010), **195** foreclosures were filed.<sup>5</sup>

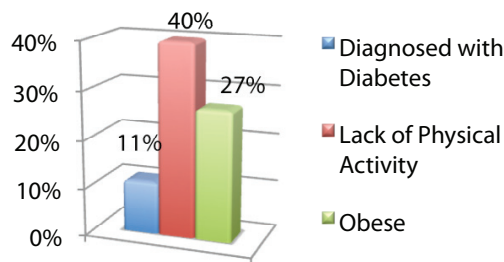
Access to health insurance is another important factor contributing to family well-being. In Montgomery County, **14%** of the people under age 65 are uninsured.<sup>8</sup>

### As a result of participation in Montgomery County Extension programs:<sup>1</sup>

- **297** people were involved in addressing issues of their community.
- **310** people increased their knowledge of governmental process.
- **380** people expanded their knowledge of economic development.
- Montgomery County Extension is involved in **25** community coalitions.

## OUR HEALTH

► The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Montgomery County. **Figure 2. Health Risks.**<sup>8</sup>



### As a result of participation in Montgomery County Extension programs:<sup>1</sup>

- **769** people increased knowledge of practices to maintain health and well-being.
- **1,011** people used safe practices to store, handle, and prepare food.
- **445** people developed skills to access affordable food.

## OUR FAMILIES

► Using data from the 2000 U.S. Census, Montgomery County families can be described as follows:<sup>2</sup>

- **6,435** families reside in the county.
- **802** families (**12.5%**) live below poverty level.
- Median family income is **\$36,939**.
- **254** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **2,269** people in Montgomery County receive supplemental nutrition assistance. The average family benefit is **\$245.37** per month.<sup>3</sup>

In the county, **25** children live in out-of-home care. There were **97**

child victims of substantiated abuse.<sup>4</sup> There were **65** incidents of adult abuse.<sup>5</sup>

### As a result of participation in Montgomery County Extension programs:<sup>1</sup>

- **981** adults and youth improved their ability to make informed and effective decisions.
- **420** people adopted money management practices to reduce debt and/or increase savings.
- **380** people increased their knowledge and skills related to parenting and personal relationships.
