Family and Consumer Sciences Extension is committed to improving the quality of life for individuals and families in Todd County resulting in strong families for Kentucky. Educational programs focus on:



2008 estimates from the 2000 U.S. Census reported total population as **11,971**.² The graph on the right indicates the percentage by age group.



SPOTLIGHT ON...

MAKING BENEFICIAL LIFESTYLE CHOICES

o increase physical activity, the Todd County Extension Agent for Family and Consumer Sciences offered America on the Move, a 12-week walking program, with six weeks each in the fall and spring. The program is dedicated to helping individuals and families make small lifestyle changes for a healthier way of life. Twenty-seven families (97 participants) enrolled; ten families (36 participants) completed all twelve weeks. Everyone used a pedometer daily to record their steps. Of the seven families who evaluated the program, 86% reported an increase in activity level; 100% said it helped them lose or maintain weight; and 100% planned to continue to be physically active.¹





OUR COMMUNITY

Unemployment rates are a key economic indicator. In July 2010, the rate of unemployment in Todd County was **10.6%**.⁶

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Todd County, **2.7%** of mortgages are 90-days delinquent and **0.5%** of bank cards

As a result of participation in Todd County Extension programs:¹


- **80** people were involved in addressing issues of their community.
- **55** people increased their knowledge of governmental process.
- **10** people were prepared to enter the work force.
- Todd County Extension is involved in **7** community coalitions.

are 60-days delinquent.⁷ In a one-year period (August 2009 through August 2010), **25** foreclosures were filed.⁵

Access to health insurance is another important factor contributing to family well-being. In Todd County, **17%** of the people under age 65 are uninsured.⁸

OUR HEALTH

The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Todd County. *Figure 2. Health Risks.*⁸



As a result of participation in Todd County Extension programs:¹

- **102** people increased knowledge of practices to maintain health and well-being.
- **38** people made lifestyle changes to improve health.
- **155** people increased their use of radon testers, smoke detectors, fire extinguishers, and other devices to ensure personal safety.

OUR FAMILIES

- Using data from the 2000 U.S. Census, Todd County families can be described as follows:²
- 3,369 families reside in the county.
- 499 families (14.7%) live below poverty level.
- Median family income is **\$36,043**.
- **123** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **800** people in Todd County receive supplemental nutrition assistance. The average family benefit is **\$245.08** per month.³

In the county, **34** children live in out-of-home care. There were **49**

child victims of substantiated abuse.⁴ There were **40** incidents of adult abuse.⁵

As a result of participation in Todd County Extension programs:¹

- **222** adults and youth improved their ability to make informed and effective decisions.
- **155** people increased their knowledge and skills related to parenting and personal relationships.
- **277** adults and youth improved practical living skills.
