OUR FOCUS


Family and Consumer Sciences

In 2010-2011, Family and Consumer Sciences Extension made **16,055** contacts with Lincoln County individuals and families.²

ACCESSING NUTRITIOUS FOODS

any Lincoln County families have gardens or purchase local foods from farmers markets to preserve them. To ensure that proper food preservation guidelines are followed, Lincoln County Family and Consumer Sciences Agent and University of Kentucky Foods and Nutrition faculty taught seven workshops in three counties. Hands-on segments taught 160 participants to preserve cooked and freezer jams, stewed tomatoes, pickled beans, and featured the use of both boiling-water and pressure canners. A majority of the participants had not canned before or had never used a pressure canner. After the program, they reported feeling more comfortable using the pressure canner. The majority reported planning to preserve foods this summer.



OUR FAMILIES

According to the 2010 Census,¹ of families in Lincoln County with their own children...

- 68.8% are husband-wife families
- 31.2% are single parent families

In addition, there are:

- 9,777 households
- **3,360** households with 1 or more persons under the age of 18
- 489 grandchildren under 18 years old who live with a grandparent householder
- **2,712** households with at least one person age 65 and over



As a result of participation in Lincoln County Extension programs:²

- 750 people increased knowledge of lifestyle changes to improve personal health.
- 100 people increased knowledge of parenting and personal relationships.
- **525** people increased knowledge of safe storage, handling and food preparation.

OUR COMMUNITY

In 2009, the most recent data available, the median household income in Lincoln County was \$31,306.3

The number of children in poverty in Lincoln County was **2,003** compared to **1,654** in 2006.³

The total number of people receiving Supplemental Nutrition Assistance Program (SNAP) benefits in Lincoln County is **5,931** in 2011.⁴

As a result of participation in Lincoln County Extension programs:²

- **155** people increased leadership knowledge and skills.
- **330** people improved communication skills to address community issues.
- 166 people developed skills to access affordable food.

OUR ECONOMY

According to the 2010 American Community Survey 5-year estimates,⁶ between 2005 and 2009 in Lincoln County it is estimated that...


- **49.2%** (+/- **5.3**) are married-couple families with both husband and wife in the labor force
- **59.5%** (+/- **12.6**) are children under 6 years old with all parents in the labor force
- 27.3% (+/- 5.7) are people 65 years and over below poverty level during the past 12 months

As a result of participation in Lincoln County Extension programs:²

- 975 people increased knowledge of economic and enterprise development.
- 100 people adopted money management practices to reduce debt and increase savings.
- **3,000** people demonstrated increased practical living skills.
