#### **OUR FOCUS**

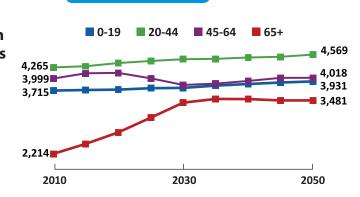
Family and Consumer Sciences Extension is committed to improving the health and well-being of individuals and families in LaRue County. To help families make wise decisions our educational programs focus on:

# MAKING HEALTHY LIFESTYLE CHOICES

tudies have shown that a reduced sodium intake can lower blood pressure, prevent hypertension, can help control hypertension, and can prevent cardiovascular disease. FCS agent taught three classes in the area to a total of 50 persons on the topic of Shake Down on Sodium. As a result of the program the top three behavior changes planned by participants are: to read food labels more closely for

sodium content and ingredients that contribute sodium; will work to decrease the amount of sodium they consume daily; and rinse canned vegetables to remove some of the salt. The class also increased their interest in doing more food preparation and home canning for themselves and using fresh herbs or other seasonings instead of salt.





#### **OUR FAMILIES**

According to the 2010 American Community Survey,<sup>3</sup> between 2006 and 2010 it is estimated that in LaRue County:

- 19.3% (+/- 6.1) families with related children were below poverty
- 10.6% (+/- 3.6) of those over the age of 65 were below poverty

#### In addition:

- 22.1% (+/- 2.1) of those ages 18-64 did not have health insurance in 2010<sup>4</sup>
- 312 children on average received Kentucky Children's Health Insurance Program (KCHIP) benefits in 2010<sup>5</sup>
- 2,727 people received Supplemental Nutrition Assistance Program (SNAP) benefits in 2012<sup>6</sup>

#### As a result of participating in LaRue County Extension programs:<sup>2</sup>

- 230 people were reached with the importance of physical activity.
- 325 people increased their knowledge about healthy foods.
- 290 people reported eating more healthy foods.

#### **OUR COMMUNITY**

#### In LaRue County:

- 55.0% of births were to mothers who received early and regular prenatal care in 2009<sup>7</sup>
- 68.0% of ordered child support was collected in 20118

Of the **4** primary care physicians in LaRue County:<sup>9</sup>

- 50.0% are family practice
- 0.0% are pediatricians
- 0.0% are OB/GYN

#### As a result of participating in LaRue County Extension programs:<sup>2</sup>

- 168 people are involved in addressing community
- 160 people implemented personal health protection practices.
- 521 people were able to utilize new decisionmaking skills for health.



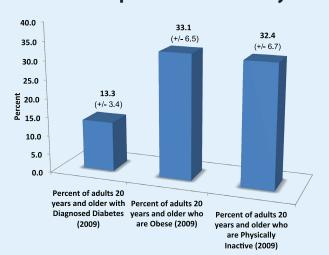
According to Kentucky Health Facts, 10 between 2008 and 2010 in LaRue County:

- 34.0% (20.3 51.0) did not pursue health care due to cost, compared to 18% (17.0 - 18.6) in the state
- 19.0% (10.6 31.6) of adults reported their health status as less than good, compared to 23% (22.0 -**23.6)** in the state
- 21.0% (12.7 32.7) of adults reported having received a flu vaccine in the past year

#### As a result of participating in **LaRue County Extension** programs:<sup>2</sup>

- **790** people increased knowledge of diet and exercise changes to improve health.
- **450** people made diet or exercise changes to improve health.
- 250 people experienced a change in knowledge of healthy home practices and stress management.
