OUR FOCUS

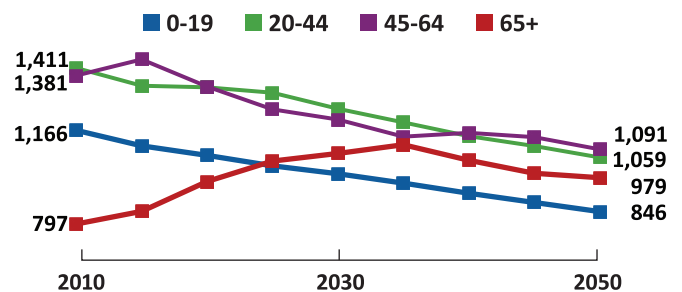
Family and Consumer Sciences Extension is committed to improving the health and well-being of individuals and families in Owsley County. To help families make wise decisions our educational programs focus on:

SPOTLIGHT ON ...

MAKING HEALTHY LIFESTYLE CHOICES

Nearly half of American adults report that they are not active at all. Seven in 10 are not moderately active for the recommended 30 to 60 minutes a day. Recently, Owsley County was ranked as the least healthy county in Kentucky, according to the "Health of KY: A County Assessment." As a result, the Owsley County Cooperative Extension Service has for the past four years provided a series of six lessons to local third-grade students utilizing the "Jump Into Food & Fitness (JIFF)" curriculum. A total of 18 sessions were presented annually, with 217 students participating in the program over the four years. One hundred percent of those participating reported that they had adopted at least one new physical activity.



OUR FAMILIES

According to the 2010 American Community Survey,³ between 2006 and 2010 it is estimated that in Owsley County:



- **48.6% (+/- 14.0)** families with related children were below poverty
- **41.1% (+/- 14.6)** of those over the age of 65 were below poverty

In addition:

- **23.9% (+/- 2.4)** of those ages 18-64 did not have health insurance in 2010⁴
- **94** children on average received Kentucky Children's Health Insurance Program (KCHIP) benefits in 2010⁵
- **2,514** people received Supplemental Nutrition Assistance Program (SNAP) benefits in 2012⁶

As a result of participating in Owsley County Extension programs:²

- **1,400** people in Plate it Up! Kentucky Proud indicated they are more likely to buy Kentucky produce.
- **10,000** people increased their knowledge about healthy foods.
- **800** people reported eating more healthy foods.

OUR COMMUNITY

In Owsley County:

- **58.0%** of births were to mothers who received early and regular prenatal care in 2009⁷
- **39.0%** of ordered child support was collected in 2011⁸

Of the **1** primary care physicians in Owsley County:⁹

- **100.0%** are family practice
- **0.0%** are pediatricians
- **0.0%** are OB/GYN

As a result of participating in Owsley County Extension programs:²

- **1,555** people are involved in addressing community issues.
- **2,800** people increased awareness of how to manage current economic events.
- **6,300** people were able to utilize new decision-making skills for health.

OUR HEALTH

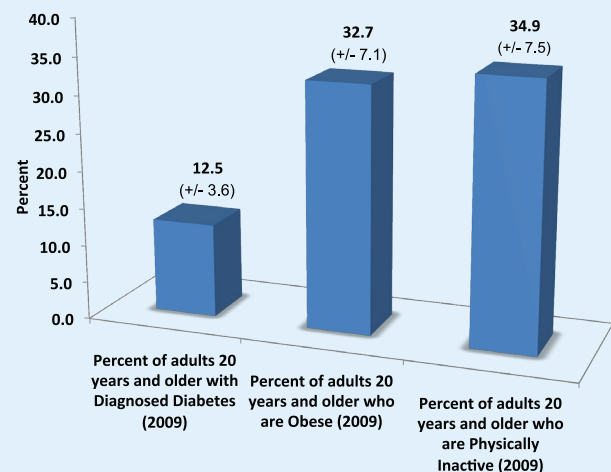
According to Kentucky Health Facts,¹⁰ between 2008 and 2010 in Owsley County:

- **24.0% (12.0 - 42.2)** did not pursue health care due to cost, compared to **18% (17.0 - 18.6)** in the state
- **35.1% (22.7 - 50.0)** of adults reported their health status as less than good, compared to **23% (22.0 - 23.6)** in the state
- **32.4% (20.9 - 46.5)** of adults reported having received a flu vaccine in the past year

As a result of participating in Owsley County Extension programs:²

- **6,300** people increased knowledge of diet and exercise changes to improve health.
- **800** people made diet or exercise changes to improve health.
- **6,300** people experienced a change in knowledge of healthy home practices and stress management.
