


OUR FOCUS

SPOTLIGHT ON ...

FITNESS IN CALDWELL COUNTY

he Trust for America's Health reports that 17.6 percent of Kentucky high school students and 21 percent of Kentucky children ages 2 to 5 are obese. The most recent "Health Education through Extension" Leadership" report concluded that 29.6 percent of Caldwell County residents are obese. It is evident that eating healthier diets and increasing physical activity are essential. The Family and Consumer Sciences staff in Caldwell County hosted a six-week FITNESS (Feel Inspired to Train and Experience Success Stories) program for 18 participants ages 9 to 14. As a result of the program, all participants learned a new physical activity. Ninety-four percent plan to continue participating in that new activity, making physical activity a part of their daily routine. Ninety-four percent also report being more conscious of their eating habits.

FAMILY ACCESS

According to the 2007-2011 American Community Survey,3 in Caldwell County...

- 33.0% (+/- 8.9) of families with children were below poverty
- 19.1% (+/- 6.0) of those ages 65 and over were below poverty
- 23.1% (+/- 3.5) of households had retirement income
- 5.7% (+/- 2.4) of households had no vehicle

The USDA Food Environment Atlas⁴ indicates that in 2010. Caldwell County had 1,497 people, 335 children and 292 seniors with low access to a supermarket or large grocery store.*

In addition, **660** residents had **both** low income **and** low access to stores.

As a result of participating in Caldwell County Extension programs:²

- 180 people increased knowledge of economic and enterprise development.
- 65 people utilized healthy food delivery systems and access points.
- 109 people were involved in addressing community

COMMUNITY AVAILABILITY

In 2011, Caldwell County had:

- 5 Grocery stores (any kind)⁵
 - 4 Grocery/supermarkets (except convenience)5
 - 1 Convenience store (i.e. food marts no gas)⁵
- 6 Gasoline stations with convenience stores⁵

In the county, there were:

- 2 Roadside markets that served the county⁶
- **0** Farmers market locations⁷
- 18 SNAP** authorized stores (food stamps)⁴
- 5 WIC*** authorized stores⁴

In 2011, there were \$262,578.55 in SNAP redemptions/per SNAP authorized store in Caldwell County.4

As a result of participating in Caldwell County Extension programs:²

- 115 people made lifestyle changes to improve health.
- 210 people implemented practices for safe storage, handling, and preparation of food.
- 685 youth reported eating more healthy foods.

FOOD ASSISTANCE

In Caldwell County...

- 968 was the average monthly number of children who received SNAP** (food stamps) in 2011, up from **726** children in 2007 (up 33.3%).9
- **60.0%** of students attending public schools were eligible for free or reduced-price meals.9
- There were 1,175 SNAP cases and the monthly SNAP benefit level was \$263.91.8


Caldwell County is served by Feeding America, Kentucky's Heartland of the Ky. Assoc. of Food Banks.¹⁰

As a result of participating in **Caldwell County Extension** programs:²

- 50 people adopted practices to increase food access and affordability.
- 160 families/caregivers were reached with information on accessing healthy foods.
- 1,189 youth increased their knowledge of healthy food consumption.
