
OUR FOCUS

SPOTLIGHT ON ...

EMPOWERING THE WORKFORCE

A ccording to the Brighton Center Annual Report 2012 concerning Campbell County, "In order for our community to be a vibrant place where hopes and dreams are realized, we must have an educated and empowered workforce." The Campbell County Family and Consumer Sciences staff provided "Small Steps to Health and Wealth" in an attempt to do just that: empower residents to set and meet personal goals. Ninety-one percent identified and set nutrition, exercise, financial and/or overall health goals, and eighty-two percent made small steps to accomplish these goals. Ninety-one percent said that as a result of the "Small Steps" program, they now make healthier food choices and get more exercise. Eighty-two percent now watch their spending more than they did prior to the program.



FAMILY ACCESS

According to the 2007-2011 American Community Survey,³ in Campbell County...

- 14.5% (+/- 2.4) of families with children were below poverty
- 7.4% (+/- 1.6) of those ages 65 and over were below poverty
- 19.0% (+/- 1.1) of households had retirement income
- 7.8% (+/- 0.9) of households had no vehicle

The USDA Food Environment Atlas⁴ indicates that in 2010. Campbell County had 27,900 people, 6,550 children and 3,744 seniors with low access to a supermarket or large grocery store.*

In addition, **5,695** residents had **both** low income **and** low access to stores.

As a result of participating in **Campbell County Extension programs:**²

- 1,458 people demonstrated an increase in practical living skills.
- 462 people utilized healthy food delivery systems and access points.
- 1,162 people were involved in addressing community issues.

FOOD ASSISTANCE

In Campbell County...

- 4,597 was the average monthly number of children who received SNAP** (food stamps) in 2011, up from **3,501** children in 2007 (up **31.3%)**.⁹
- 49.0% of students attending public schools were eligible for free or reduced-price meals.9
- There were 5,616 SNAP cases and the monthly SNAP benefit level was \$271.73.8

Campbell County is served by Freestore Foodbank of the Ky. Assoc. of Food Banks.¹⁰

As a result of participating in **Campbell County Extension** programs:²

- 631 people supplemented their diets with healthy foods they produced or preserved.
- 2,464 people were reached with information on accessing healthy foods.
- 1,536 youth increased their knowledge of healthy food consumption.

COMMUNITY AVAILABILITY

In 2011, Campbell County had:

- 25 Grocery stores (any kind)⁵
 - 17 Grocery/supermarkets (except convenience)⁵
 - 8 Convenience stores (i.e. food marts no gas)⁵
- 35 Gasoline stations with convenience stores⁵

In the county, there were:

- 2 Roadside markets that served the county⁶
- 5 Farmers market locations⁷
- 77 SNAP** authorized stores (food stamps)⁴
- 17 WIC*** authorized stores⁴

In 2011, there were \$276,991.39 in SNAP redemptions/per SNAP authorized store in Campbell County.⁴


As a result of participating in **Campbell County Extension programs:**²

- 1,829 people increased knowledge of lifestyle changes to improve personal health.
- 810 people implemented practices for safe storage, handling, and preparation of food.
- 703 people reported eating more healthy foods.
