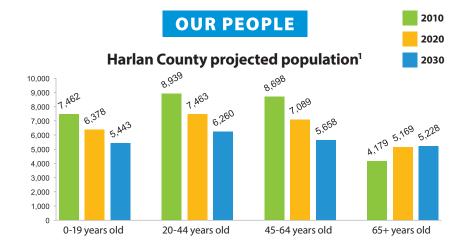


OUR FOCUS

SPOTLIGHT ON ...

SHOPPING MATTERS

ncreased consumption of unhealthy foods, stress, and lack of physical activity are largely responsible for obesity, which contributes toward other chronic illnesses that plague Kentucky. In cooperation with the county diabetes education grant, the Harlan County Extension Service hosted a program called "Shopping Matters," including a hands-on supermarket activity designed to teach how to make healthy food purchases on a limited budget. Eighteen people received hands-on practice. Sixteen of the 18 individuals took the challenge of making several healthy food purchases while keeping the total cost under \$10. In a formal evaluation, 100 percent of the 16 who took the \$10 challenge learned several new shopping techniques and ideas on how to save money.

FAMILY ACCESS

According to the 2007-2011 American Community Survey,3 in Harlan County...

- 37.6% (+/- 5.0) of families with children were below poverty
- **18.2%** (+/- 4.5) of those ages 65 and over were below poverty
- 22.8% (+/- 2.3) of households had retirement income
- 12.1% (+/- 2.0) of households had no vehicle

The USDA Food Environment Atlas⁴ indicates that in 2010. Harlan County had 5,086 people, 1,161 children and 766 seniors with low access to a supermarket or large grocery store.*

In addition, **2,904** residents had **both** low income **and** low access to stores.

As a result of participating in Harlan County Extension programs:²

- 1,300 people demonstrated an increase in practical living skills.
- 110 people in Managing in Tough Times: Moneywi\$e became aware of how to manage current economic events.
- 325 people were involved in addressing community issues.

COMMUNITY AVAILABILITY

In 2011, Harlan County had:

- 11 Grocery stores (any kind)⁵
 - 10 Grocery/supermarkets (except convenience)5
 - 1 Convenience store (i.e. food marts no gas)⁵
- 11 Gasoline stations with convenience stores⁵

In the county, there were:

- 1 Roadside markets that served the county⁶
- **0** Farmers market locations⁷
- 53 SNAP** authorized stores (food stamps)⁴
- 17 WIC*** authorized stores⁴

In 2011, there were **\$287,406.01** in SNAP redemptions/per SNAP authorized store in Harlan County.4

As a result of participating in Harlan County Extension programs:²

- 475 people made lifestyle changes to improve personal health.
- 850 people implemented practices for safe storage, handling, and preparation of food.
- 800 families spent time together in physical activity.

FOOD ASSISTANCE

In Harlan County...

- 3,233 was the average monthly number of children who received SNAP** (food stamps) in 2011, down from **3,305** children in 2007 (down **2.2%**).9
- **71.0%** of students attending public schools were eligible for free or reduced-price meals.9
- There were **5,894** SNAP cases and the monthly SNAP benefit level was \$255.68.8

Harlan County is served by God's Pantry Food Bank of the Ky. Assoc. of Food Banks.¹⁰

As a result of participating in Harlan County Extension programs:²

- 56 people in Plate it Up! Kentucky Proud indicated they are more likely to buy Kentucky produce.
- 1,200 youth were reached with information on eating healthy foods.
- **500** people were reached with information on accessing healthy foods.
