
OUR FOCUS

SPOTLIGHT ON ...

HEALTHY HOLIDAY COOKING

To address high rates of obesity among Kentucky adults, the McCreary County Cooperative Extension Service developed a Healthy Holiday Cooking program. The interactive program focused on healthy ingredient substitutions for traditional holiday recipes, on food safety to combat food borne illness, and on the replacement of traditional holiday foods with more nutritious, yet satisfying alternatives. Surveys completed at the end of the program indicated: 77 percent of the participants reported increased knowledge in preparation of healthy holiday recipes; 72 percent reported a better understanding of food safety and preparation recommendations, and 96 percent planned to use one of the healthy recipes sampled at the program.



FAMILY ACCESS

According to the 2007-2011 American Community Survey,³ in McCreary County...

- 34.4% (+/- 7.9) of families with children were below poverty
- 17.7% (+/- 6.8) of those ages 65 and over were below poverty
- 15.8% (+/- 3.2) of households had retirement income
- 9.8% (+/- 2.8) of households had no vehicle

The USDA Food Environment Atlas⁴ indicates that in 2010. McCreary County had 866 people, 238 children and 100 seniors with low access to a supermarket or large grocery store.*

In addition, 635 residents had **both** low income **and** low access to stores.

As a result of participating in **McCreary County Extension programs:**²

- 455 people increased knowledge of healthy food consumption.
- 30 people adopted one or more practices to reduce debt or increase savings.
- 10 people were involved in addressing community issues.

COMMUNITY AVAILABILITY

In 2011, McCreary County had:

- 7 Grocery stores (any kind)⁵
 - 4 Grocery/supermarkets (except convenience)⁵
 - 3 Convenience stores (i.e. food marts no gas)⁵
- 11 Gasoline stations with convenience stores⁵

In the county, there were:

- 1 Roadside market that served the county⁶
- 0 Farmers market locations⁷
- 33 SNAP** authorized stores (food stamps)⁴
- 13 WIC*** authorized stores⁴

In 2011, there were \$257,346.08 in SNAP redemptions/per SNAP authorized store in McCreary County.⁴

As a result of participating in McCreary County Extension programs:²

- 150 people increased their knowledge of safe storage, handling and preparation of food.
- 283 people increased knowledge of lifestyle changes to improve personal health.
- 195 people reported eating more healthy foods.

FOOD ASSISTANCE

In McCreary County...

- 2,086 was the average monthly number of children who received SNAP** (food stamps) in 2011, up from **1,998** children in 2007 (**up 4.4%**).⁹
- 76.0% of students attending public schools were eligible for free or reduced-price meals.9
- There were 3,276 SNAP cases and the monthly SNAP benefit level was \$257.52.8


McCreary County is served by Purchase Area Development District Food Bank of the Ky. Assoc. of Food Banks.¹⁰

As a result of participating in McCreary County Extension programs:²

- 170 people made lifestyle changes to improve personal health.
- 420 people were reached with information on accessing healthy foods.
- 235 youth increased their knowledge of healthy food consumption.
