


OUR FOCUS

SPOTLIGHT ON ...

HEALTHY SNACKS FOR YOUTH

n an effort to lessen the incidence of chronic diseases in future generations, the Robertson County Family and Consumer Sciences staff and volunteers developed a program to teach children how to cook healthy snacks and meals. In its third year, the after-school monthly classes continue to average more than 25 elementary youth and 10 adults per session. Program evaluations revealed that the youth developed satisfactory cooking skills; 92 percent learned a lot about the importance of cleanliness and proper hand-washing; and 84 percent said they now cook more and try to eat healthier at home. Parents reported that their children are more patient during meal preparation and now help with meals in productive ways.

FAMILY ACCESS

According to the 2007-2011 American Community Survey,3 in Robertson County...

- 32.6% (+/-20.4) of families with children were below poverty
- 15.0% (+/-10.3) of those ages 65 and over were below poverty
- 22.8% (+/-7.0) of households had retirement income
- 6.3% (+/-4.0) of households had no vehicle

The USDA Food Environment Atlas⁴ indicates that in 2010. Robertson County had 1,705 people, 368 children and 307 seniors with low access to a supermarket or large grocery store.*

In addition, **873** residents had **both** low income **and** low access to stores.

As a result of participating in **Robertson County Extension programs:**²

- 105 people demonstrated an increase in practical living skills.
- 150 people utilized healthy food delivery systems and access points.
- 24 people in Plate it Up! Kentucky Proud indicated they are more likely to buy Kentucky produce.

COMMUNITY AVAILABILITY

In 2011, Robertson County had:

- 1 Grocery store (any kind)⁵
 - 1 Grocery/supermarket (except convenience)5
 - O Convenience stores (i.e. food marts no gas)⁵
- O Gasoline stations with convenience stores⁵

In the county, there were:

- 2 Roadside markets that served the county⁶
- **0** Farmers market locations⁷
- 4 SNAP** authorized stores (food stamps)⁴
- 0 WIC*** authorized stores4

In 2008, there were \$18,986 in SNAP redemptions/per SNAP authorized store in Robertson County.

As a result of participating in Robertson County Extension programs: 2

- 45 people made lifestyle changes to improve health.
- 55 people implemented practices for safe storage, handling, and preparation of food.
- 160 people increased knowledge of healthy food consumption.

FOOD ASSISTANCE

In Robertson County...

- **186** was the average monthly number of children who received SNAP** (food stamps) in 2011, up from **132** children in 2007 (up **40.9%**).9
- **61.0%** of students attending public schools were eligible for free or reduced-price meals.9
- There were 229 SNAP cases and the monthly SNAP benefit level was \$288.03.8


Robertson County is served by God's Pantry Food Bank of the Ky. Assoc. of Food Banks.¹⁰

As a result of participating in **Robertson County Extension** programs:2

- 130 people adopted practices to increase food access and affordability.
- 420 families/caregivers were reached with information on accessing healthy foods.
- 181 youth increased their knowledge of healthy food consumption.
