# COMMUNITY WALKING PROGRAM

The Fleming County Cooperative Extension Office implemented a six-week walking program for employees of local businesses. A total of 27 teams, with 153 participants, attended the program. The teams logged a total of 15,347 miles throughout the program. During lunch breaks, participants used tracks at the city reservoir and the industrial park. Evaluations showed that 100% of the participants view physical activity as important. All participants also reported that they plan to continue to walk at least 3 to 5 days a week for 30 minutes per day. Various participants reported achieving some of the following goals: weight loss, lower blood pressure or cholesterol numbers, and improved self-esteem.


#### **AVAILABILITY**

In 2010, in Fleming County, there were...<sup>3</sup>

- 1,304 renter households
- 4,425 homeowner households
- 180 vacant housing units for rent
- 102 vacant housing units for sale

According to the Kentucky Department of Education, in 2012-2013, **77** children were homeless or were precariously housed in Fleming County.4

# **HEALTH AND SAFETY**

In Fleming County, it is estimated that in 2008-2012...<sup>2</sup>

- half of all renter-occupied housing was built before 1977 (+/-7 years)
- half of all owner-occupied housing was built before 1983 (+/-3 years)

According to 2008-2012 American Community Survey<sup>2</sup> estimates in Fleming County...

- 4.3% (+/- 2.3) of all households had no landline or cell phone
- 42.9% (+/- 5.2) of workers living in Fleming County worked in Kentucky but outside the county and 2.1% (+/-0.8) worked outside the state
- Half of all workers traveled **27.0** (+/- 2.2) or more minutes to work

#### **AFFORDABILITY**


According to American Community Survey estimates for Fleming County, in 2008-2012...<sup>2</sup>

- **30.0%** (+/- 9.1) of renter households paid **35%** or more of their income for rent and utilities
- 27.3% (+/- 5.0) of homeowner households with a mortgage and 15.1% (+/- 5.0) of homeowner households without a mortgage paid 35% or more of their income for housing costs
- 44.7% (+/- 3.5) of homeowner households did not have a mortgage
- **30.9%** (+/- 3.7) of all housing units were mobile homes

According to the most recent poverty estimates, in 2012, **20.5%** (+/- 3.7) of residents in the county were living below poverty.5

In 2013, residents needed to earn \$10.87 an hour (or work 1.5 iobs at \$7.25 an hour\*\*) to afford a twobedroom apartment at Fair Market Rent in Fleming County.6
