OUR FOCUS

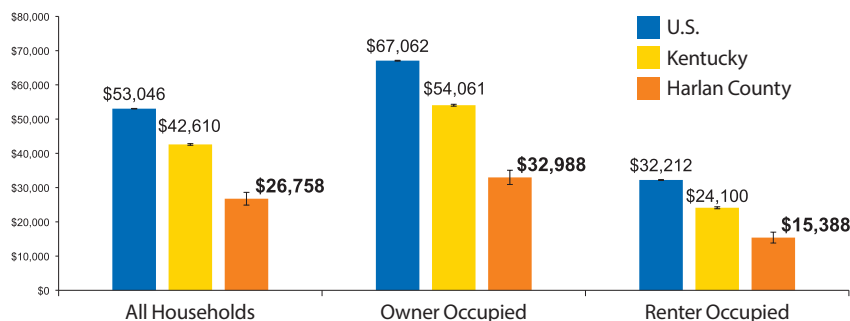
Family and Consumer Sciences Extension is committed to improving the health and well-being of individuals and families in Harlan County. To help families make wise decisions, our educational programs focus on:

SPOTLIGHT ON ...

PLATE IT UP! KENTUCKY PROUD

People are encouraged to buy locally grown commodities in the "Plate It Up! Kentucky Proud" classes, a joint program of the U.S. Department of Agriculture and the Cooperative Extension Service. The program emphasizes creating a healthy lifestyle and reducing obesity, which endangers one-third of the adults in Harlan County. Classes included hands-on cooking activities that used program recipe cards. Class information focused on selection, storage, and preparation of fruits and vegetables. The program reached 155 people, and in evaluations, 100% said the recipe cards influenced their decision to buy fresh produce after the classes. More than half indicated they plan to consume more fruits and vegetables and 100% improved their skills in preparing foods and had better nutritional habits.

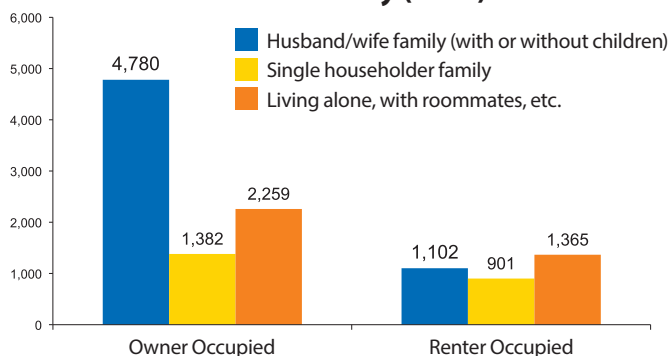
AVAILABILITY

In 2010, in Harlan County, there were...³

- **3,368** renter households
- **8,421** homeowner households
- **423** vacant housing units for rent
- **121** vacant housing units for sale

According to the Kentucky Department of Education, in 2012-2013, **1,129** children were homeless or were precariously housed in Harlan County.⁴

HEALTH AND SAFETY

In Harlan County, it is estimated that in 2008-2012...²

- half of all renter-occupied housing was built before **1976** (+/- 3 years)
- half of all owner-occupied housing was built before **1972** (+/- 3 years)

According to 2008-2012 American Community Survey² estimates in Harlan County...

- **5.3%** (+/- 1.3) of all households had no landline or cell phone
- **11.1%** (+/- 2.2) of workers living in Harlan County worked in Kentucky but outside the county and **4.0%** (+/- 1.3) worked outside the state
- Half of all workers traveled **24.5** (+/- 1.9) or more minutes to work

AFFORDABILITY

According to American Community Survey estimates for Harlan County, in 2008-2012...²

- **36.6%** (+/- 6.4) of renter households paid **35%** or more of their income for rent and utilities
- **24.1%** (+/- 4.6) of homeowner households with a mortgage and **7.5%** (+/- 1.9) of homeowner households without a mortgage paid **35%** or more of their income for housing costs
- **63.5%** (+/- 2.5) of homeowner households did not have a mortgage
- **22.8%** (+/- 2.1) of all housing units were mobile homes

According to the most recent poverty estimates, in 2012, **29.5%** (+/- 3.7) of residents in the county were living below poverty.⁵

In 2013, residents needed to earn **\$10.87** an hour (or work **1.5** jobs at \$7.25 an hour**) to afford a two-bedroom apartment at Fair Market Rent in Harlan County.⁶
