### OUR FOCUS

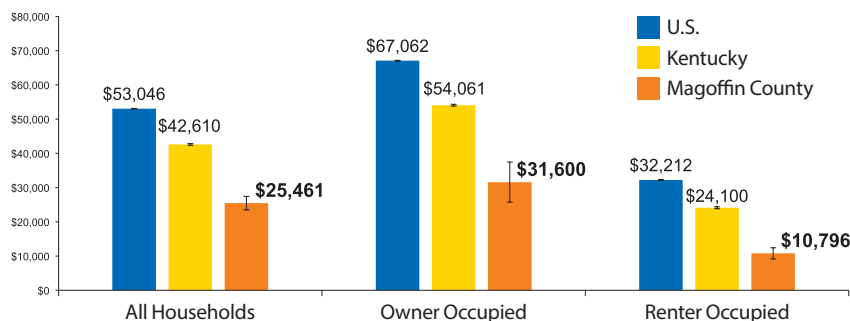
Family and Consumer Sciences Extension is committed to improving the health and well-being of individuals and families in Magoffin County. To help families make wise decisions, our educational programs focus on:

## DAWKINS TRAIL WALKING PROGRAM

According to the 2013 Kentucky BRFSS, 61.5% adults participate in leisure-time physical activity in the Big Sandy area. The Magoffin County Extension Service promoted a walking program as a leisure-time physical activity on the Dawkins Trail Line. Eighteen adults and four youth participated in the eight-week walking program. In a survey before the program, only 45% said they used walking as part of their exercise routine. No one reported using of pedometers to count steps. The group met once a week to walk one to two hours. On average, participants walked 3,500 steps daily and reported they started to walk more often as part of their daily exercise.

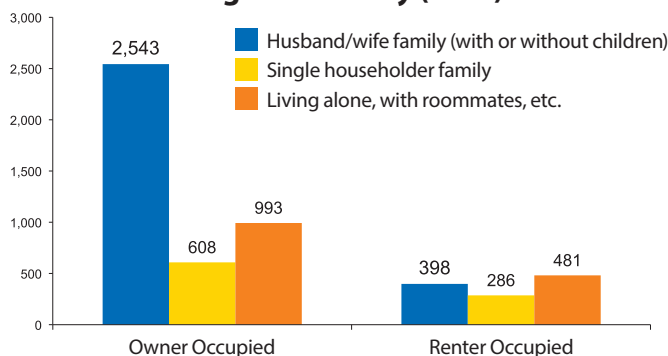
## AVAILABILITY

In 2010, in Magoffin County, there were...<sup>3</sup>

- **1,165** renter households
- **4,144** homeowner households
- **115** vacant housing units for rent
- **30** vacant housing units for sale

According to the Kentucky Department of Education, in 2012-2013, **168** children were homeless or were precariously housed in Magoffin County.<sup>4</sup>

## HEALTH AND SAFETY

In Magoffin County, it is estimated that in 2008-2012...<sup>2</sup>

- half of all renter-occupied housing was built before **1980** (+/- 4 years)
- half of all owner-occupied housing was built before **1985** (+/- 2 years)

According to 2008-2012 American Community Survey<sup>2</sup> estimates in Magoffin County...

- **5.9%** (+/- 1.9) of all households had no landline or cell phone
- **34.4%** (+/- 6.1) of workers living in Magoffin County worked in Kentucky but outside the county and **1.1%** (+/- 1.2) worked outside the state
- Half of all workers traveled **29.7** (+/- 3.9) or more minutes to work

## AFFORDABILITY

According to American Community Survey estimates for Magoffin County, in 2008-2012...<sup>2</sup>

- **56.8%** (+/- 11.4) of renter households paid **35%** or more of their income for rent and utilities
- **24.7%** (+/- 7.9) of homeowner households with a mortgage and **13.0%** (+/- 4.1) of homeowner households without a mortgage paid **35%** or more of their income for housing costs
- **70.5%** (+/- 4.0) of homeowner households did not have a mortgage
- **47.1%** (+/- 4.0) of all housing units were mobile homes

According to the most recent poverty estimates, in 2012, **31.2%** (+/- 5.8) of residents in the county were living below poverty.<sup>5</sup>

In 2013, residents needed to earn **\$10.87** an hour (or work **1.5** jobs at \$7.25 an hour\*\*) to afford a two-bedroom apartment at Fair Market Rent in Magoffin County.<sup>6</sup>
