OUR FOCUS

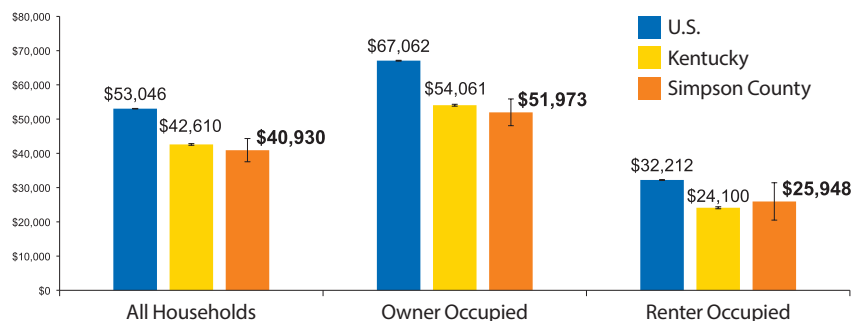
Family and Consumer Sciences Extension is committed to improving the health and well-being of individuals and families in Simpson County. To help families make wise decisions, our educational programs focus on:

HEALTHY LIVING GROUP

Due to client requests and a recognized community need for a focused emphasis on better health, the Healthy Living Class was formed in Simpson County. Efforts were made to keep the group motivated by taking small steps toward healthy lifestyle changes, weight loss, and overall better health. Total weight loss for the group is over 80 pounds. Additional outcomes include an increase in exercise (100%), improved portion control (100%), increased consumption of fruits and vegetables (100%) and improved snack choices. One participant has quit smoking, which has improved her ability to breathe and increased her income.

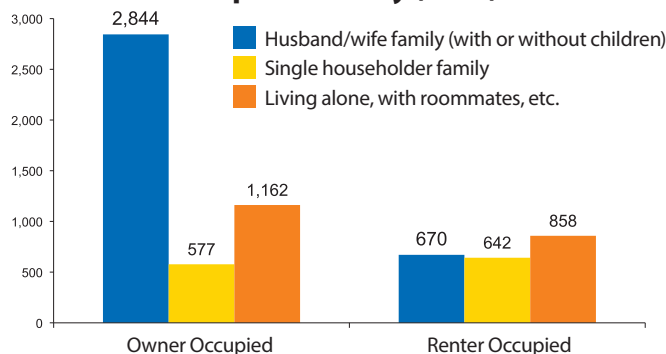
AVAILABILITY

In 2010, in Simpson County, there were...³

- **2,170** renter households
- **4,583** homeowner households
- **206** vacant housing units for rent
- **116** vacant housing units for sale

According to the Kentucky Department of Education, in 2012-2013, **49** children were homeless or were precariously housed in Simpson County.⁴

HEALTH AND SAFETY

In Simpson County, it is estimated that in 2008-2012...²

- half of all renter-occupied housing was built before **1972** (+/- 4 years)
- half of all owner-occupied housing was built before **1978** (+/- 3 years)

According to 2008-2012 American Community Survey² estimates in Simpson County...

- **2.7%** (+/- 1.1) of all households had no landline or cell phone
- **20.4%** (+/- 3.3) of workers living in Simpson County worked in Kentucky but outside the county and **12.5%** (+/- 2.4) worked outside the state
- Half of all workers traveled **20.5** (+/- 1.6) or more minutes to work

AFFORDABILITY

According to American Community Survey estimates for Simpson County, in 2008-2012...²

- **39.0%** (+/- 7.3) of renter households paid **35%** or more of their income for rent and utilities
- **19.2%** (+/- 5.2) of homeowner households with a mortgage and **10.9%** (+/- 4.1) of homeowner households without a mortgage paid **35%** or more of their income for housing costs
- **37.4%** (+/- 3.6) of homeowner households did not have a mortgage
- **6.3%** (+/- 1.9) of all housing units were mobile homes

According to the most recent poverty estimates, in 2012, **18.0%** (+/- 3.2) of residents in the county were living below poverty.⁵

In 2013, residents needed to earn **\$12.02** an hour (or work **1.7** jobs at \$7.25 an hour**) to afford a two-bedroom apartment at Fair Market Rent in Simpson County.⁶
