# BASIC HOME REPAIRS

The Wolfe County FCS Advisory Council identified the need to help citizens better manage their budgets by doing their own basic home repairs. As a result, the FCS agent partnered with the local rural electric cooperative to offer programs to teach participants how to use basic tools to perform simple home repairs, how certain repairs can conserve energy, and to share tips on hiring a dependable contractor. Several program participants shared what they learned with others and called the electric company to set up a home energy audit. Extension continues to get calls from others requesting information on simple home repairs.


#### **AVAILABILITY**

In 2010, in Wolfe County, there were...<sup>3</sup>

- 876 renter households
- 2,189 homeowner households
- 83 vacant housing units for rent
- 25 vacant housing units for sale

According to the Kentucky Department of Education, in 2012-2013, 8 children were homeless or were precariously housed in Wolfe County.4

#### **HEALTH AND SAFETY**

In Wolfe County, it is estimated that in 2008-2012...<sup>2</sup>

- half of all renter-occupied housing was built before 1979 (+/-5 years)
- half of all owner-occupied housing was built before 1982 (+/-3 years)

According to 2008-2012 American Community Survey<sup>2</sup> estimates in Wolfe County...

- 11.2% (+/- 4.6) of all households had no landline or cell phone
- 41.0% (+/- 8.0) of workers living in Wolfe County worked in Kentucky but outside the county and 0.7% (+/- 1.1) worked outside the state
- Half of all workers traveled 27.5 (+/- 4.1) or more minutes to work

#### **AFFORDABILITY**


According to American Community Survey estimates for Wolfe County, in 2008-2012...<sup>2</sup>

- **64.5%** (+/- 12.9) of renter households paid **35%** or more of their income for rent and utilities
- **29.9%** (+/- 10.7) of homeowner households with a mortgage and 12.8% (+/- 5.5) of homeowner households without a mortgage paid 35% or more of their income for housing costs
- 67.0% (+/- 5.6) of homeowner households did not have a mortgage
- **37.2%** (+/- 5.3) of all housing units were mobile homes

According to the most recent poverty estimates, in 2012, **36.6%** (+/- 6.4) of residents in the county were living below poverty.5

In 2013, residents needed to earn \$12.17 an hour (or work 1.7 jobs at \$7.25 an hour\*\*) to afford a twobedroom apartment at Fair Market Rent in Wolfe County.6
