### OUR FOCUS



## WALK WITH EASE

The Cooperative Extension Service partnered with the Purchase District Health Department on Walk with Ease, a six-week National Arthritis Foundation program. Three leaders were trained and certified to teach the program. Of the 10 women and one man who participated, seven had arthritis and four did not. The program includes walking, health education, stretching and strengthening exercises, motivational tips and tools, and socialization. Eight of the 11 completed the program. In a survey, all said they learned warm-up and cool-down exercises and how to walk safely and comfortably. After six weeks, a number were walking twice as many laps as when they began.

## FINANCIAL WELL-BEING

In Ballard County, the median household income in 2013 was **\$42,712 (+/- \$4,115)** compared to \$43,307 (+/- \$631) for the state.<sup>3</sup>

The American Community Survey estimates that between 2009-2013:<sup>4</sup>

- **19.3% (+/-6.2)** of families with related children were below poverty
- **9.7% (+/-4.0)** of people age 65 and over were below poverty
- **2.8% (+/-1.7)** of individuals working full time/full year in the previous 12 months were below poverty
- **51.4%** of students were eligible for free lunches and **4.5%** were eligible for reduced-price lunches in 2014-2015<sup>5</sup>

### As a result of participating in Ballard County Extension programs:<sup>1</sup>

- **134** people demonstrated informed and effective decision-making.
- **243** people demonstrated increased practical living skills.

## PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Ballard County in 2012:<sup>6</sup>

- **13.9% (18.0%-10.5%)** of adults reported having been diagnosed with diabetes
- **35.2% (42.3%-28.1%)** of adults 18 years and over were obese
- **33.2% (40.8%-26.0%)** of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Ballard County:<sup>7</sup>

- **43.8% (56.0%-32.3%)** of adults reported having been diagnosed with high blood pressure
- **26.9% (35.1%-20.0%)** of adults reported fair or poor health

In Ballard County:

- **20.1%** had adequate access to locations for physical activity compared to 72.0% for the state<sup>8</sup>
- **31.6% (+/-6.6)** of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)<sup>8</sup>
- **0-9** deaths were from a drug overdose between 2009-2013<sup>9</sup>

### As a result of participating in Ballard County Extension programs:<sup>1</sup>

- **77** people increased knowledge of lifestyle changes to improve personal health.
- **1,498** children and youth learned to eat more healthy food.

## SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Ballard County:<sup>4</sup>

- **31.4% (+/-1.9)** of households included one or more persons age 65 and over
- **132 (+/-61)** grandparents lived with and were responsible for their own grandchildren
- **54.2% (+/-15.2)** of children under 6 years and **59.1% (+/-11.5)** of children 6-17 years had all parents in the labor force
- **139 (+/-63)** of those age 5 and older spoke a language other than English at home
- **739 (+/-109)** civilian veterans lived in Ballard County<sup>4</sup>


In Ballard County:

- **18.4% (27.4%-11.9%)** of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-12<sup>7</sup>
- **20** children were determined to have been victims of child abuse or neglect in 2013<sup>10</sup>
- **57.3%** of those registered to vote did so in the 2014 General Election<sup>11</sup>

### As a result of participating in Ballard County Extension programs:<sup>1</sup>

- **54** adults reported increased leadership skills, knowledge or confidence.
- **48** people were reached with information related to health and safety.
