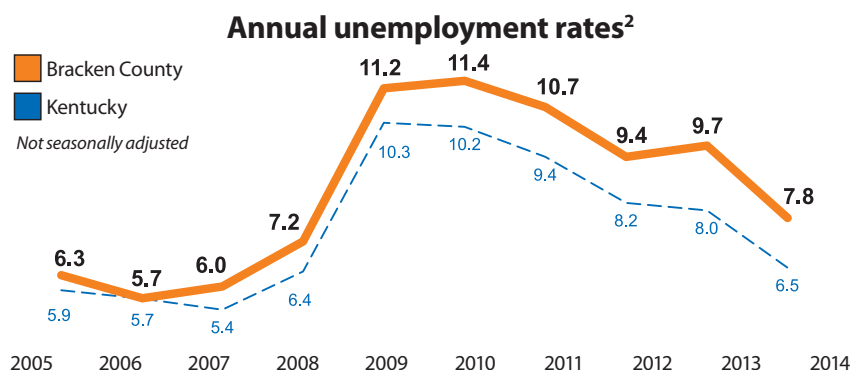
### OUR FOCUS

Family and Consumer Sciences (FCS) Extension is committed to improving the health and well-being of individuals and families in Bracken County. To help Kentuckians strengthen their financial, physical, and social well-being, our educational programs focus on:

## YOUTH LEARN CONSEQUENCES OF DRUG ABUSE

After a spike in the abuse of prescription and illegal drugs, Bracken County Cooperative Extension offered the Truth and Consequences program to all 8th graders. The program was held at the Bracken County Judicial Center, which allowed courtrooms and jail cells to be used to illustrate points. About 20 community partners, parents, and volunteers assisted, and 125 students attended the two sessions. Evaluations showed that students' awareness increased in regard to drug and alcohol laws. Parents said they were eager for their other children to attend in the future.

## FINANCIAL WELL-BEING

In Bracken County, the median household income in 2013 was **\$43,222 (+/- \$4,289)** compared to \$43,307 (+/- \$631) for the state.<sup>3</sup>

The American Community Survey estimates that between 2009-2013:<sup>4</sup>

- **20.0% (+/-5.2)** of families with related children were below poverty
- **15.2% (+/-5.7)** of people age 65 and over were below poverty
- **5.0% (+/-2.5)** of individuals working full time/full year in the previous 12 months were below poverty
- **57.3%** of students were eligible for free lunches and **7.2%** were eligible for reduced-price lunches in 2014-2015<sup>5</sup>

### As a result of participating in Bracken County Extension programs:<sup>1</sup>

- **238** people demonstrated informed and effective decision-making.
- **485** people learned and used new leadership skills.

## PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Bracken County in 2012:<sup>6</sup>

- **13.0% (16.0%-10.3%)** of adults reported having been diagnosed with diabetes
- **30.7% (35.8%-25.8%)** of adults 18 years and over were obese
- **29.6% (34.8%-24.8%)** of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Bracken County:<sup>7</sup>

- **36.3% (45.3%-28.2%)** of adults reported having been diagnosed with high blood pressure
- **24.5% (30.2%-19.6%)** of adults reported fair or poor health

In Bracken County:

- **3.1%** had adequate access to locations for physical activity compared to 72.0% for the state<sup>8</sup>
- **56.0% (+/-7.9)** of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)<sup>8</sup>
- **0-9** deaths were from a drug overdose between 2009-2013<sup>9</sup>

### As a result of participating in Bracken County Extension programs:<sup>1</sup>

- **577** people increased knowledge of lifestyle changes to improve personal health.
- **498** children and youth learned to eat more healthy food.

## SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Bracken County:<sup>4</sup>

- **29.1% (+/-1.9)** of households included one or more persons age 65 and over
- **167 (+/-105)** grandparents lived with and were responsible for their own grandchildren
- **56.3% (+/-12.6)** of children under 6 years and **63.7% (+/-12.2)** of children 6-17 years had all parents in the labor force
- **109 (+/-38)** of those age 5 and older spoke a language other than English at home
- **571 (+/-109)** civilian veterans lived in Bracken County<sup>4</sup>

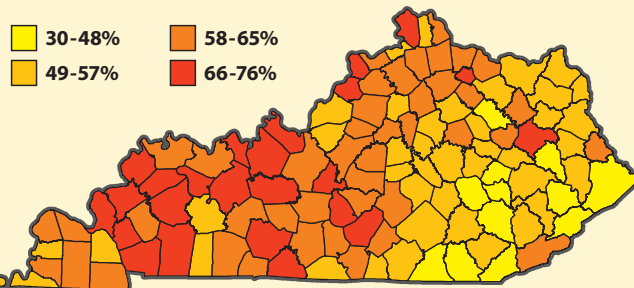
In Bracken County:

- **25.0% (32.5%-18.8%)** of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-12<sup>7</sup>
- **92** children were determined to have been victims of child abuse or neglect in 2013<sup>10</sup>
- **42.9%** of those registered to vote did so in the 2014 General Election<sup>11</sup>

### As a result of participating in Bracken County Extension programs:<sup>1</sup>

- **42** people were involved in addressing community issues.
- **372** people were reached with information related to health and safety.
