OUR FOCUS

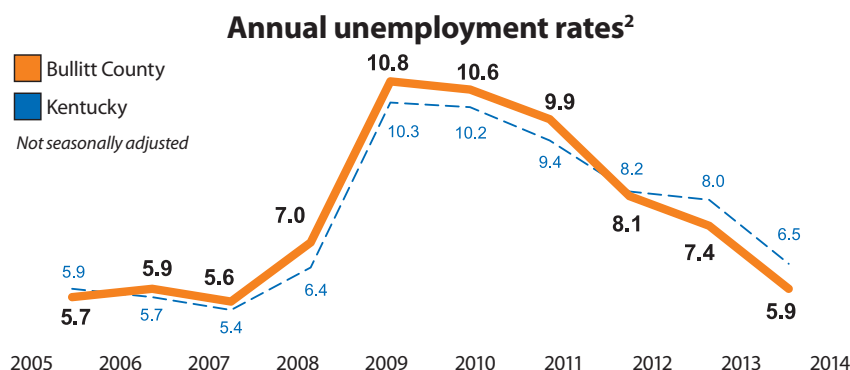

SPOTLIGHT ON...

INMATES LEARN TO BE BETTER FATHERS

The Bullitt County Extension Service taught a 13-week class called Nurturing Fathers to 40 inmates in the substance abuse program at the local detention center. Using lectures, journaling, play acting, and skits, the participants learned parenting skills. An evaluation assessed participants on their level of risk for child abuse. Results showed that 71% made significant progress in lowering their risk score for abuse, 61% lowered their risk for child abuse from high to medium, 92% committed to fathering without violence, and 68% felt prepared to practice the skills and attitudes of a nurturing father.

FINANCIAL WELL-BEING

In Bullitt County, the median household income in 2013 was **\$57,462 (+/- \$3,787)** compared to \$43,307 (+/- \$631) for the state.³

The American Community Survey estimates that between 2009-2013:⁴

- **12.2% (+/-2.4)** of families with related children were below poverty
- **7.1% (+/-1.6)** of people age 65 and over were below poverty
- **1.5% (+/-0.6)** of individuals working full time/full year in the previous 12 months were below poverty
- **43.1%** of students were eligible for free lunches and **5.4%** were eligible for reduced-price lunches in 2014-2015⁵

As a result of participating in Bullitt County Extension programs:¹

- **28** people demonstrated informed and effective decision-making.
- **506** people received Moneywi\$e educational resources.

PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Bullitt County in 2012:⁶

- **11.9% (14.9%-9.3%)** of adults reported having been diagnosed with diabetes
- **32.6% (37.8%-27.8%)** of adults 18 years and over were obese
- **33.2% (38.5%-28.2%)** of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Bullitt County:⁷

- **42.6% (53.6%-32.3%)** of adults reported having been diagnosed with high blood pressure
- **20.7% (26.9%-15.7%)** of adults reported fair or poor health

In Bullitt County:

- **72.1%** had adequate access to locations for physical activity compared to 72.0% for the state⁸
- **43.2% (+/-2.9)** of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)⁸
- **63** deaths were from a drug overdose between 2009-2013⁹

As a result of participating in Bullitt County Extension programs:¹

- **28** people increased knowledge of lifestyle changes to improve personal health.
- **503** children and youth learned to eat more healthy food.

SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Bullitt County:⁴

- **23.6% (+/-0.7)** of households included one or more persons age 65 and over
- **1,100 (+/-277)** grandparents lived with and were responsible for their own grandchildren
- **74.4% (+/-5.5)** of children under 6 years and **78.5% (+/-3.5)** of children 6-17 years had all parents in the labor force
- **1,231 (+/-204)** of those age 5 and older spoke a language other than English at home
- **5,928 (+/-430)** civilian veterans lived in Bullitt County⁴

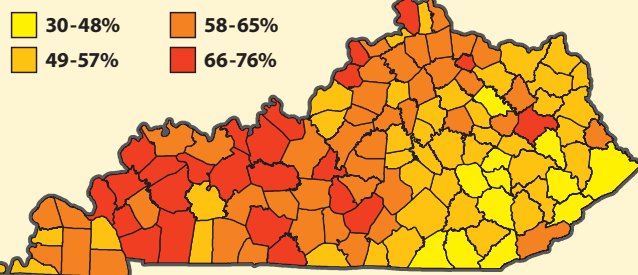
In Bullitt County:

- **21.4% (29.1%-15.2%)** of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-12⁷
- **153** children were determined to have been victims of child abuse or neglect in 2013¹⁰
- **44.0%** of those registered to vote did so in the 2014 General Election¹¹

As a result of participating in Bullitt County Extension programs:¹

- **46** adults reported increased leadership skills, knowledge or confidence.
- **1,184** people were reached with information related to health and safety.
